Survey III Full Time Equivalency (FTE) for student data was completed on February 7, 2025.

Bus Evacuation Workshops were scheduled for the following dates, February 12th-13th. The workshop on the 12th was completed, but due to the inclement weather on the 13th, the workshop was rescheduled to March 17th, 2025. The following training courses were completed by all that attended the workshop.

- Driver Training Course: Emergency Evacuations -Teaches drivers how to safely evacuate the bus under various circumstances.
- Evacuation Planning for Students with Special Needs Drivers and bus attendants must be prepared to implement an effective safety plan quickly if the bus must be evacuated.

Wheelchair Training for all ESE drivers and bus attendants was completed on February 11th, 2025.

• School bus drivers and transportation staff are tasked with the important responsibility of safely conveying students in wheelchairs in their vehicles. This course will cover the differences among various types of wheelchairs and the correct ways to secure them to your vehicle and the importance of using the fourpoint tie-down securement system to ensure the safety of wheelchair users during transportation. After completing this course participants will have a comprehensive understanding of wheelchair securement and safety on school buses and be equipped with the knowledge and skills necessary to provide safe and accessible transportation for all passengers.

#### **Media and Technology**

The Data and voice networks are up and running throughout the district. We are updating, repairing and providing support as evidence by the list below.

- <u>Havana Magnet School</u>- During the past 30 days HMS experienced a network outage. This outage affected both the phone and internet at the school. The Vendor AT&T experienced a fiber cut. This has happened twice during the past 30 days. We worked with the schools and the vendor to expedite the restoration of services
- <u>GCHS-</u> The school site experienced a 3-day outage during the past 30 days. The outage was caused by a third-party vendor hardware failure. We were able to find a backup connection for internet access. We will be working to prioritize both voice and data traffic through direct connection with the district office. Due to the sporadic outages occurring at the school, we have a Comcast connection along with the AT&T connection supplying services to the school. A backup phone line has been installed. The back up line will not be affected by loss of service from the vendor
- <u>Stewart Street Elementary School</u>- The HVAC construction is complete. The repair of the Audio system was approved by the Board at the last meeting and the work has begun. We have also begun the upgrade of network assets at Stewart St with the new Fortinet hardware to include new wireless access points, switches, etc. We will assist in implementing the Mentoring program in the upcoming month.
- <u>GEMS</u>- Chromebooks 30 Delivered by Principal's Request.

#### Volunteer Services & Families in Transition Services

- TOY has been selected, and application has been submitted to the state office for consideration as the State of Florida DOE 2026 TOY of the year. We are grateful for those that served on the nominating committee and the interview panel. Congratulations to our TOY, Mrs. Ashley Uchebo, as well as all the schools' representatives.
- The department rolled out the new state initiative the Resiliency Coach training to help support our students with overcoming struggles in life and equipping them with skills to be more resilient. The first orientation for those coaches is slated to be held this Spring.
- On February 6, 2025, we hosted our Collaborative Partners' meeting and had (19) organizations/partners represented. From this meeting, we have secured (4) signed MOUs to help support our students and families with more anticipated being completed for the 24-25 school year.
- Over the past two months, the department has supported (7) families with uniforms and food requests. The department is currently awaiting approval for a \$20,000 uniform order to ensure that we are adequately stocked to support our students and families. The department has been actively supporting the schools with the McKinney-Vento required presentation and ensuring staff is aware of the requirements needed to adequately support our students and families.

#### Truancy & Attendance Compliance Services

- Over the past two (2) months, there have been (13) attendance intervention meetings held throughout the district to support our students with attending school regularly, as well as assisting families with ensuring students have resources to be successful.
- We are continuing to support schools with student support to work toward improving attendance, with the hopes of decreasing the **49.8%** (*2123/4256*) of our students who are below 90% attendance. Additionally, we have begun work on the implementation of the reporting phases of the attendance implementation model, to include notifying DMV of students with driving privileges, which now sits at over (**250**) students.

#### Home Education & Virtual Instruction Office

- We are continuing to enroll home education database, to include K12 and PAEC FLVS Franchise, whereas since 1/6/2025 there have been (11) letters of intent, (13) notice of terminations and (1) annual evaluation reported; and this includes (4) new enrollments in the PAEC FLVS Franchise.
- Our first Virtual Instruction Program Parent Expo was held (12/11/24) we provided information and reoriented families to the expectations of those enrolled in the district's virtual instruction program. We are constantly providing insight and information to parents and schools on the process of home education & virtual instruction programs.

#### Action Steps:

- Planning to host our next Parent Liaisons' & Volunteer Coordinators' meeting for Monday, March 17, 2025.
- Working to develop climate surveys for students, parents, school/district staff, as well as community members to gather pertinent information to improve the services offered by the district to begin facilitating in **May 2025**.
- Plans for the end of the year recognition event is underway to ensure that we recognize those teachers and support staff who have exemplified outstanding achievement over the past year to be held in May 2025.
- Developing the action plan for our next family/community meeting to be held in April 2025.
- Working with United Way of the Big Bend to kick-off our donation campaign, with the campaign period slated for March 24<sup>th</sup> April 4<sup>th</sup>.
