4. Discussion: New CTAE Building Placement

Superintendent Shannon M. Dillard discussed the scope and sequence of the new CTAE building with the board, focusing on the long-term vision for enhancing the future use of the surrounding property

and facilities. The goal is to compile the information collected along with focusing on the timeframe of the work to obtain a guaranteed maximum price (GMP) for the project and utilize the approved Construction Manager (CM) at Risk for the CTAE building.

5. Discussion: Current CTAE Demolition

After discussing the vision for the new CTAE building and its location, the next step is to determine what will happen to the existing CTAE building with a proposed plan of demolition. Superintendent Shannon M. Dillard discussed the process required to phase out an existing building with the Board. The Capital Outlay Programs (COPS) have a specific order and process for schools to utilize when building and closing facilities. Because our system utilizes COPS funding, we will adhere to their guidance and timelines.
