I would like to inform each of you that I will be retiring effective March 31, 2024.

I have truly enjoyed working for the Marengo County School System and I sincerely appreciate the support provided to me during my 24 years as Superintendent. It has been a complete privilege and pleasure to work with the present and past school Board members, Central Office staff, principals, faculties, support employees, students, and communities. It made waking up and coming to work each day a pleasure.

I treasure the improvements we have made during my tenure which include:

- ➤ Academic improvement at all three schools.
- ➤ Adding Reading and Math Coaches along with a system-wide Instructional Leader.
- > Providing all students with Chromebooks.
- ➤ Adding up-to-date technology in all classrooms,
- > Providing on-line and dual enrollment classes.
- Adding a system-wide Mental Health Coordinator.
- > Getting full-time counselors, librarians, and principals at all schools no matter their size.

- Creating a salary matrix for support employees.
- ➤ Working with the State Department of Education to restructure our 10-mill match
- Managing our finances to where we are in the best position we have been in many years.

The students and families in our district are fortunate to have such a dedicated and talented staff throughout our school system.
