**I Preliminaries of the Meeting**

At 6:00 P.M., Board President Mr. Jason Heany declared a quorum and called the meeting to order.

~The Governor has signed the state budget for the 2025-2026 school year, which includes full funding of the formula, transportation, and the Teacher Baseline Salary Grant.

~New staff will report on August 8, 2025, and all staff will return to school on August 11, 2025.

~He has asked the attorney to proceed with dropping the April ballot issue. The district will rerun the tax levy in either November 2025 or April 2026. A list of possible ballot names can be found in the Superintendent's report.

~The next Board of Education meeting will be held on August 14, 2025.

- A. Mr. Brad Hunter presented the Alternative Methods of Instruction (AMI) Plan for approval. Mr. Ryan Hoffman moved with a second by Dr. Jamie Burkhart to approve the AMI Plan for the 2025-2026 School Year. Motion carried 6-0.
- B. 25-26 Meal Price Approval

The meal prices will be presented for approval at the August Board of Education (BOE) meeting.
- C. Mr. Brad Hunter presented the SY 25-26 WHS Parent/Student Handbook, SY 25-26 WES Parent/Student Handbook, and SY 25-26 Athletic Handbook for an initial reading. Handbooks will be completed and brought to the August Board of Education (BOE) meeting for approval.
