Peter F. School Responsibilities

Peter F. Alba Middle School will:

- 1. Provide high-quality curriculum and instruction in a supportive and effective learning environment that enables the participating children to meet the State’s student academic achievement standards as follows:**
 - Students will be provided rigorous, relevant, and engaging assignments that reinforce classroom instruction using scientific research-based best practices and foster success.
 - Students will be taught necessary skills and concepts in an aligned curriculum to meet state standards.
 - Teachers will facilitate student learning by incorporating various instructional methods.
- 2. Hold parent-teacher conferences (at least annually in elementary schools) during which this compact will be discussed as it relates to the individual child’s achievement.** Specifically, those conferences will be held:
 - Parents will be invited to attend a school-wide Open House during the first month of school to meet teachers and discuss student concerns.
 - Parents will be invited to participate in State-wide Parenting Day activities at the local school. Teachers will be available to conduct Partnership Conferences during which standardized test scores from the previous year will be discussed and a plan of action will be forged to facilitate student success.
- 3. Provide parents with frequent reports on their children’s progress.** Specifically, the school will provide reports as follows:
 - Student progress can be monitored by parents daily utilizing Schoology. All parents will be provided log-in information to access their child’s grades.
 - Report cards will be disseminated at the end of each quarter.
 - Parents of students in need of additional academic support or in danger of failing will be notified by teachers
- 4. Provide parents reasonable access to staff.** Specifically, staff will be available for consultation with parents as follows:
 - Staff will be available throughout the year (by appointment) to meet with parents. Appointments may be scheduled before or after school by contacting the school at 251-824-4134.
- 5. Provide parents opportunities to volunteer and participate in their child’s class, and to observe classroom activities,** as follows:
 - Parents will be given the opportunity to volunteer, participate, and observe classroom activities at any time with approval from the school principal and does not disrupt the normal educational process.
- 6. Ensure regular two-way, meaningful communication between family members and school staff, and, to the extent practicable, in a language that family members can understand.**
 - School newsletters and other parent communications will be provided in native language as requested.
 - The school will provide an interpreter to translate between family and school staff when necessary.

Parent Responsibilities

We, as parents, will support our children’s learning in the following ways:

- Monitoring attendance.
- Making sure that homework is completed.
- Volunteering in my child’s classroom.
- Participating, as appropriate, in decisions relating to my children’s education.
- Promoting positive use of my child’s extracurricular time.

- Serving, to the extent possible, on advisory groups, such as Title I advisory committees and parent and family engagement committees.
