- -We are making efforts with limiting our spending in order to accommodate our Small Necessary School Budget: The former Reading Specialist has been moved to a grant funded position, The current Librarian/Reading Specialist has volunteered to work less hours and be placed on a Personal Service Agreement, other costs are also being cut.

- -We strive to incorporate 'relative' extracurricular activities that interest our student and family population in order to attract more families and increase our ADA.
- -Keenan has been a struggle to get enrolled with this last school-year. We are good to go this school-year.

Response to letters from public: All students' work remained as theirs for Independent Study. There is no bullying of students or staff at this school that is coming from Administration. The California Teachers Association (CTA) had performed a full investigation based on two false complaints via interviewing all staff and has a clear report on Administration and any type of harassment. The CTA interviewer even noted what a lovely staff we have and that they only had good compliments about administration, aside from the staff member who made the false complaints. Administration has had multiple investigations that were sparked because of the abundance of false claims that have been reported by a few former staff and their constituents. The School Board receives every report for every investigation. The School Board looks at and watches Administration with a careful eye. They also give directives and redirection if they see something they would like Administration to do or if they see something they would not like Administration not to do. They have a collective heart for the children and desire safety, learning, and compassion for all on campus. There has been no fraudulent activity from Administration since 2019, with the hire of Misti Livingston. Misti has brought the school into compliance for many topics. There have been many audits and investigations with standing reports. Administration has not and will not slander any family. No employee has been wrongfully terminated from Oak Run Elementary School. Administration works very closely and transparently with our Legal Counsel and School Board when it comes to personnel issues. A full investigation was performed by Law Enforcement because the false complaints of Administration stealing money from Oak Run School District. After the investigation, Law Enforcement reported that there are no money crimes performed by Administration. The public speakers stated that Dede Masala lied and that she was not a witness to an event that happened on campus. The Sherriff's report does not suggest in any way that Mrs. Masala was witness to this event. It only states that she was a witness and that merely means that she was spoken to by the Sherriff on call. Masala did not say/claim that she was a witness to this event. As far as time cards go, employees are not to be paid hours that they did not work, unless they request paid time off. The complainant attempted to claim hours that she did not work and that was corrected and she was notified of the corrections. All records act requests have been followed up on. This administration is an outstanding citizen of Oak Run, California. She puts more into Oak Run School in the form of time, money, and effort than what has been put in by other Administration in many years. She is dedicated to the success of every student, staff member, community member, and Board member should they accept it. Her boundaries do not sway. She stands for safety, learning, and compassion for all people. She has not even gone back at the folks who have attacked her credibility time and time again with many profound and false complaints.
