<u>Antioch Baptist Church:</u> The recipient will be chosen by church representatives. No description has been given for this scholarship.

Annette Armstrong Memorial Scholarship: Student must Two scholarships will be given. Requirements are having a 3.0 GPA, going to a college (tech or a 4 year degree), and financial need will be a major consideration. Complete the local scholarship application. You have to complete the essay of Advantages of a College Education.

**Ava Hayes Memorial:** The recipient will be chosen by the family of Ava Hayes. Students must have a 2.5 or higher GPA.

<u>Ballard County ASAP:</u> In addition to the local scholarship application, students must submit an essay on the topic of "How Substance Abuse Has Impacted my Life and My Thoughts on Prevention" (minimum of 250 words)

**Ballard County Bus Drivers:** The recipient is chosen by a committee of bus drivers for Ballard County Schools. **No application is necessary.** 

**Ballard County Conservation District:** The recipient of this scholarship must be willing to go into the agriculture or agribusiness field of study.

**Ballard County Education Association:** The recipient of this scholarship will be the child or grandchild of a BCEA member. He/she must apply through the BMHS guidance office, and have at least a B grade average. The recipient will receive a check upon enrollment in a college or university.

**Ballard County Farm Bureau:** The recipient may plan to attend either a college or vocational/technical school. The recipient's parent or guardian must be a member of Ballard County Farm Bureau.

**Ballard County Homemakers:** The recipient must major in home economics, agriculture or related fields. The student may receive the scholarship up to (but not over) four consecutive years.

<u>Ballard Memorial Alumni Association:</u> The recipient shall demonstrate high academic standards. Citizenship and financial need shall be a consideration.

**Ballard Rural Telephone Co-op:** The recipient must be a student whose parent or guardian is a member of or is served by Ballard Telephone Corp. The recipient shall have a 3.0 GPA or better and must pursue further education at a university, college or vocational/technical school. Upon enrollment, a check will be sent to the college of the recipient's choice.

Barlow First Baptist Church: Church members will be given first priority in receiving the Dathel Crews Norment, Thomas Taylor Norment, Eva Sanders Moore, Darrel E. "Preacher" Moore and Jerry D. and Connie S. Moore scholarships. These awards are to recognize students who have demonstrated a record of attendance at church services and activities, good moral/ethical character, and have completed high school with a GPA and test scores necessary to continue their education. The committee will evaluate all applicants and determine their merit as recipients. A separate application must be obtained-please do not use the local scholarship application. <u>Beta Club:</u> The recipient must be a senior Beta Club member who exhibits leadership and citizenship, with strong academic ability. The recipient will receive a check upon enrollment in an accredited institution.

**<u>Betty T. Lane Memorial Scholarship:</u>** The recipient of this scholarship must have a 3.0 GPA.

Bob Buchanan Memorial Scholarship: No description provided. Open to everyone.

Class of 1957 Scholarship: No requirements for this scholarship. Open to everyone.

<u>Class of 1994 Memorial Scholarship:</u> The recipient of this scholarship will be chosen by a committee of 1994 class officers and graduates.

<u>Class of 2010 Memorial Scholarship:</u> The recipient of this scholarship will be chosen by a committee of 2010 class officers and graduates.

**Channel Your Brave:** The "Channel Your Brave" Scholarship is awarded to a senior student who has shown outstanding poise, perseverance and courage in facing whatever life has presented. The recipient of this award has made difficult divisions and sacrifices for the sake of others and done so with grace.

<u>Chris Pigg Memorial Scholarship:</u> In Memory of Chris Pigg, a student at Ballard Memorial High School. His family would like to recognize a student planning to continue their education at a post-secondary institution.

<u>City of Wickliffe Scholarship:</u> Students must be a resident of Wickliffe and have at least a 3.0 GPA or higher.

<u>Clifton C. and Ruth Perkins:</u> The recipient of this scholarship is chosen by a committee.

Connie Bray Memorial Scholarship - Open to everyone

<u>Dr. W.N. Coffee Memorial Scholarship:</u> Students shall submit a resume including personal data, academic standing, extracurricular activities, future plans, expected major in school, where the student plans to attend and why the student feels he or she should receive this scholarship.

**FFA Alumni Scholarship-** Must be in FFA for 3 or more years, have competed in a competition, been to multiple chapter, regional or state events and be in good standings with the advisor and chapter.

<u>The Giving Tree:</u> Recipient must be a senior, and plan to attend a college or tech school the semester following graduation. Minimum 2.0 GPA, and trouble-free last two years of high school. Complete the local scholarship application and a 250 word essay, using a word form the shop's logo and telling what that word means to you. Also, please include extracurricular activities with your essay.

**Holman and Olyn Boyd:** The recipient of this award will be chosen based on financial need, GPA, class rank, leadership qualities and career choice.

Ingevity Leader Scholarship: Applicant must show leadership skills and carry a 3.0 GPA at the end of his/her junior year. Five on-time scholarships of \$2,000 will be awarded to students enrolled in 14 area high schools. At least one scholarship will be awarded to the child/dependent of a Ingevity employee planning to pursue postsecondary education, one will be awarded to a student planning to major in STEM fields of study in a college/university, and two will be awarded to candidates planning to attend trade schools. <u>Kerrie Stewart Memorial Scholarship:</u> Applicant must plan to attend **Western Kentucky University** (**WKU**), must have demonstrated leadership qualities in high school, and must have high academic standing. Students planning to major in advertising shall be given priority consideration.

**Tot Waldon Family:** Preference will be given to a senior who plans to attend MSU or WKCTC. Financial need is a priority.

**Tommy Case Memorial Scholarship:** No description given.
