## **Plan Descriptions**

During the 2020-2021 School Year, Happy Valley Elementary has been involving families, staff, board and community members in multiple stakeholder engagement opportunities. Surveys have been deployed since the beginning of the pandemic to determine needs such as social emotional, connectivity, learning loss and technology needs. This school year, several town hall meetings and surveys have been sent regarding reopening plans, hybrid and full opening to determine the percentage of parents and families that were comfortable with returning to school. A survey was sent to parents, community, board and staff to determine LCAP priorities that focus on accelerating student learning and continued learning opportunities for this year and next. These opportunities provided the necessary feedback on what types of intervention programs to make available for students in ELA, Math, counseling, on going professional development and social emotional well being.

A description of how students will be identified and the needs of students will be assessed.

Happy Valley School District will use a variety of resources to identify students in need of academic, social emotional and other integrated supports. Theses resources will be used on going throughout the year at either 4-6 week or 12 intervals. Students will be identified for ELA support though our Fountas and Pinell benchmark system K-6. These assessments will be given each Trimester with recommendation for support if the student is below grade level reading. In Math, the students will be given the locally created math benchmark from Engage NY to access grade level proficiency. An intervention teacher will be serving the students on a one on one basis or in small targeted groups. Students who need social emotional support will continue to access our SEL counselor. Each teacher will continue to utilize Peacebuilders, our in class social emotional learning curriculum.

A description of how parents and guardians of students will be informed of the opportunities for supplemental instruction and support.

Happy Valley School District will provide on-going communication regarding the opportunities that are available for students in ELA, Math and SEL. Any student identified through the assessment process that needs extra support for learning acceleration, the parent will be reached by a phone call and letter in the parents' language. Parents and guardians will also receive ongoing updates on their child's progress if they are receiving supplemental supports.

Students who are identified will be served both in the classroom and with an intervention teacher who will target their curricular needs. Paraprofessionals who are already in the classroom will work with the identified students when needed. Teachers will also modify the class work if it is determined, and a counselor will continue to be available to students who need. The students can access the counselor either by parent or teacher referral. Continued use of the Peacebuilder curriculum will be our SEL program and each month, the classes will follow a SEL theme with activities around that theme.

A description of how ELO Grant funds are being coordinated with other federal Elementary and Secondary School Emergency Relief Funds received by the LEA.

HVS will use these funds in conjunction with IPI funds, ESSER II and ESSER III funds. All of these funds will be used to support students that are not achieving grade level or benchmarks. Intervention teacher, SEL counselor and paraprofessionals will be used to address any academic gaps. In addition, new chromebooks and Ipads will be purchased to support student learning.

An LEA receiving ELO Grant funds under *EC* Section 43521(b) is required to implement a learning recovery program that, at a minimum, provides supplemental instruction, support for social and emotional well-being, and, to the maximum extent permissible under the guidelines of the United States Department of Agriculture, meals and snacks to, at a minimum, students who are included in one or more of the following groups:

- low-income,
- English learners,
- foster youth,
- homeless students,
- students with disabilities,
- students at risk of abuse, neglect, or exploitation,
- disengaged students, and
- students who are below grade level, including, but not limited to, those who did not enroll in kindergarten in the 2020–21 school year, creditdeficient students, high school students at risk of not graduating, and other students identified by certificated staff.

For purposes of this requirement

- "Supplemental instruction" means the instructional programs provided in addition to and complementary to the LEAs regular instructional programs, including services provided in accordance with an individualized education program (IEP).
- "Support" means interventions provided as a supplement to those regularly provided by the LEA, including services provided in accordance with an IEP, that are designed to meet students' needs for behavioral, social, emotional, and other integrated student supports, in order to enable students to engage in, and benefit from, the supplemental instruction being provided.
- "Students at risk of abuse, neglect, or exploitation" means students who are identified as being at risk of abuse, neglect, or exploitation in a written referral from a legal, medical, or social service agency, or emergency shelter.

*EC* Section 43522(b) identifies the seven supplemental instruction and support strategies listed below as the strategies that may be supported with ELO Grant funds and requires the LEA to use the funding only for any of these purposes. LEAs are not required to implement each supplemental instruction and support strategy; rather LEAs are to work collaboratively with their community partners to identify the supplemental instruction and support strategies that will be implemented. LEAs are encouraged to engage, plan, and collaborate on program operation with community partners and expanded learning programs, and to leverage existing behavioral health partnerships and Medi-Cal billing options in the design and implementation of the supplemental instruction and support strategies are:

- 1. Extending instructional learning time in addition to what is required for the school year by increasing the number of instructional days or minutes provided during the school year, providing summer school or intersessional instructional programs, or taking any other action that increases the amount of instructional time or services provided to students based on their learning needs.
- 2. Accelerating progress to close learning gaps through the implementation, expansion, or enhancement of learning supports including, but not limited to, any of the following:
  - a. Tutoring or other one-on-one or small group learning supports provided by certificated or classified staff.
  - b. Learning recovery programs and materials designed to accelerate student academic proficiency or English language proficiency, or both.
  - c. Educator training, for both certificated and classified staff, in accelerated learning strategies and effectively addressing learning gaps, including training in facilitating quality and engaging learning opportunities for all students.
- Integrated student supports to address other barriers to learning, such as the provision of health, counseling, or mental health services, access to school meal programs, before and after school programs, or programs to address student trauma and social-emotional learning, or referrals for support for family or student needs.
- 4. Community learning hubs that provide students with access to technology, high-speed internet, and other academic supports.
- 5. Supports for credit deficient students to complete graduation or grade promotion requirements and to increase or improve students' college eligibility.
- 6. Additional academic services for students, such as diagnostic, progress monitoring, and benchmark assessments of student learning.
- 7. Training for school staff on strategies, including trauma-informed practices, to engage students and families in addressing students' socialemotional health needs and academic needs.

As a reminder, *EC* Section 43522(g) requires that all services delivered to students with disabilities be delivered in accordance with an applicable IEP.

#### **Fiscal Requirements**

The following fiscal requirements are requirements of the ELO grant, but they are not addressed in this plan. Adherence to these requirements will be monitored through the annual audit process.

- The LEA must use at least 85 percent (85%) of its apportionment for expenditures related to providing in-person services in any of the seven purposes described above.
- The LEA must use at least 10 percent (10%) of the funding that is received based on LCFF entitlement to hire paraprofessionals to provide supplemental instruction and support through the duration of this program, with a priority for full-time paraprofessionals. The supplemental instruction and support provided by the paraprofessionals must be prioritized for English learners and students with disabilities. Funds expended to hire paraprofessionals count towards the LEAs requirement to spend at least 85% of its apportionment to provide in-person services.
- An LEA may use up to 15 percent (15%) of its apportionment to increase or improve services for students participating in distance learning or to support activities intended to prepare the LEA for in-person instruction, before in-person instructional services are offered.
