PART I: INSTRUCTION TO BIDDERS

Greenville Area School District is receiving sealed bids for the sale of a 2013 Dodge Grand Caravan.

1.1 BID CONDITIONS

1. Bids proposals are due by 1:00p.m. on Friday, July 31, 2026 to the District Administration Offices located at 9 Donation Road, Greenville, PA 16125 at which time they will be publicly opened.
2. No bid will be recorded unless the Bid Proposal Form, as shown at the end of this document, is completed and signed by the bidder.
3. The minimum bid amount to be accepted shall be \$2,000.
4. It is understood and agreed that the equipment is sold as is.
5. All bids will be effective for 30 days from the date of the bid opening and no bid may be withdrawn during that period except as permitted by law.
6. The Greenville Area School District does not obligate itself to accept the lowest or any bids, and particularly reserves the right to reject any or all bids and to waive any informalities in the bidding process.
7. The Greenville Area School District will not discriminate in its educational programs, activities or employment practices, based on race, color, national origin, sex, disability, age, religion, ancestry, union membership, or any other legally protected classification. Announcement of this policy is in accordance with state and federal laws, including Title IX of the Education Amendments of 1972, and Sections 503 and 504 of the Rehabilitation Act of 1973.

1.4 ON-SITE INSPECTION

On-site inspection of the equipment shall be made available to on **Wednesday, July 29, 2026 from 9:00 a.m. to 2:00 p.m.** in the parking lot of the Snyder-Stone Stadium Field House located at 9 Donation Road, Greenville, PA 16125.

1.5 PAYMENT

The successful bidder will be notified within five working days of the bid opening. At that time of notification, within five working days the successful bidder must submit a bank or certified check to the Greenville Area School District for the total amount bid as originally proposed.

If payment is not satisfied as described above by the successful bidder, the Greenville Area School District shall have the right to disqualify such bidder and nullify such previously communicated award.

1.6 INSURANCES, PLATES, TAXES & FEES

It is the responsibility of the successful bidder to fulfil any state license, insurance or registration requirements upon completion of the sale. Furthermore, it is the responsibility of the successful bidder to pay for applicable taxes and fees incurred for the legal transfer of the equipment.

It is the responsibility of the Greenville Area School District, upon satisfaction of payment by the successful bidder, to coordinate the time and place of which the title transfer will be completed and physical exchange of the equipment shall be completed.

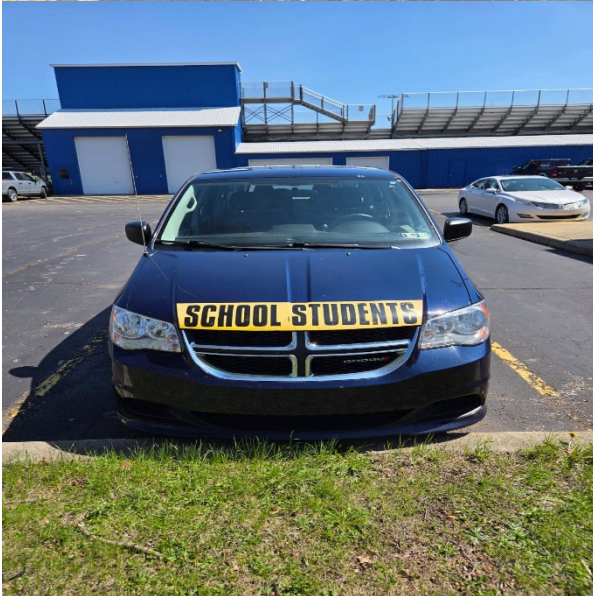
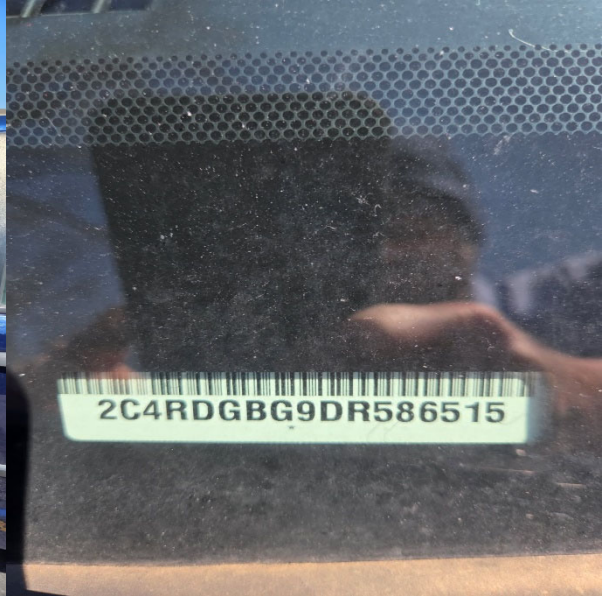

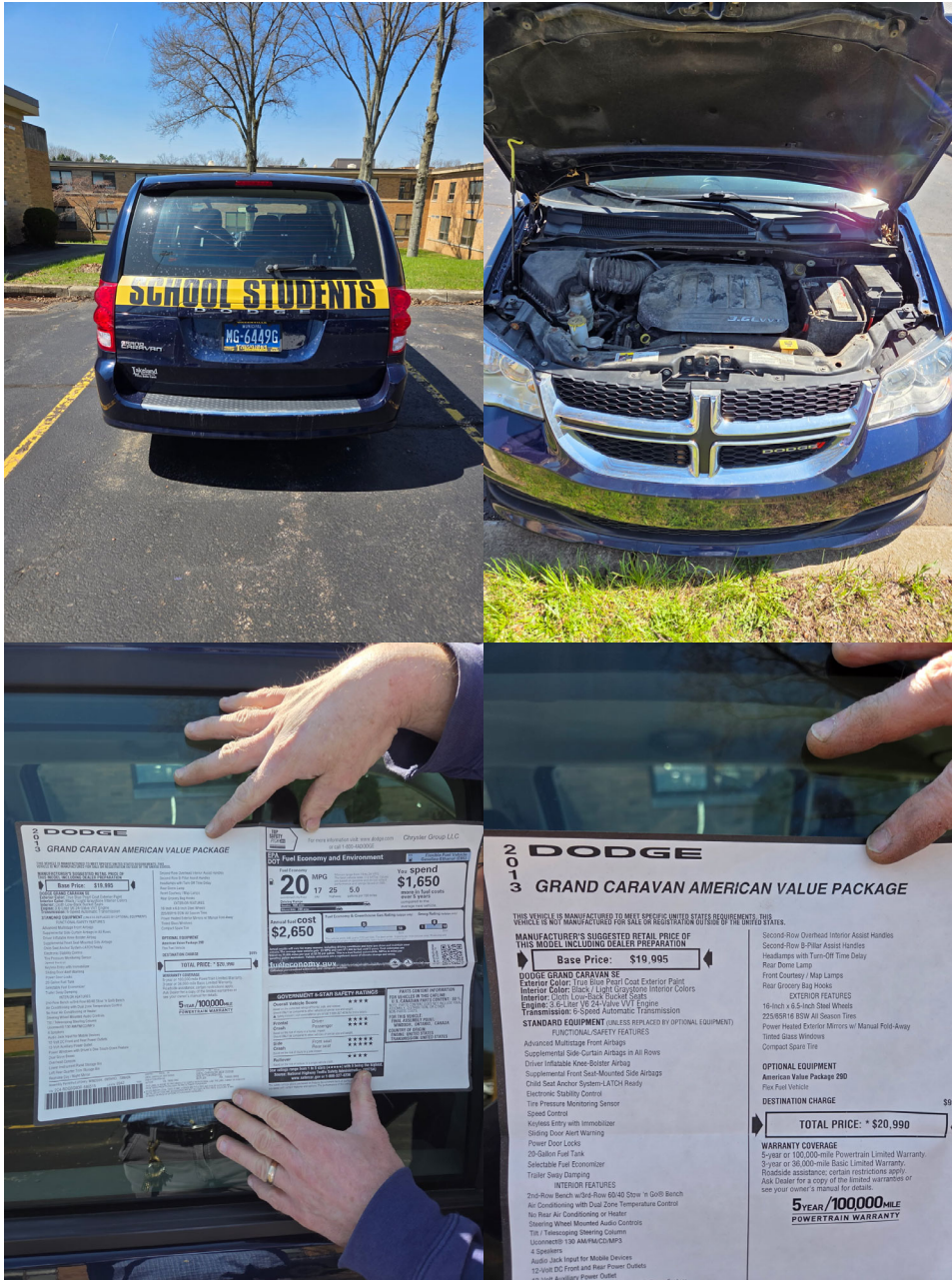
