**Moved by Maria Mennella, seconded by Steven Slattery, that the Rocky Hill Board of Education adopts the expulsion period imposed by the Wethersfield Board of Education and expels the student from June 8, 2023, until June 7, 2024. During the period of the expulsion, the student will be provided with an alternative educational opportunity as deemed appropriate by the administration. In addition, the Board authorizes the Superintendent of Schools, in his sole discretion, to readmit the student to school on the first day of the second semester (late January 2024) if the student meets the conditions established by the Wethersfield Board of Education, as outlined in that Board's decision. During the period of expulsion, the student shall not be allowed on school grounds or allowed to participate in any school-sponsored activities without proper approval from the Superintendent of Schools.**
