The Summer Food Service Program (SFSP) Administrative Review (AR) of Gadsden County School Board was conducted on September 6, 2018 by staff members from the Division of Food Nutrition, and Wellness (FNW), Florida Department of Agriculture and Consumer Services. The month of review was July 2018. An exit conference was conducted after the completion of the on-site portion of the AR on September 6, 2018 as required under Federal Regulation 7 CFR, Section 225.7. The following areas were included in the review: Meal Counts, Program Expenses, Sponsor Monitoring, State Review Monitoring, Health Inspections, Ethnic/Racial Data Collection, Civil Rights and Procurement.

Results: Based on our review, findings were identified in the following areas.

Meal Counts

The sponsor must ensure accuracy in meal counts prior to submission of the claim for reimbursement. Meal counts were validated for ten sites. Two sites had meal count errors for July 2018. Meals count errors consisted of the following:

Identified Finding(s):

In numerical order, each number on the meal count sheet must be marked as each child is served. The marks should equal the total meals served by the site. The marks on the form did not match the total meals served.

Please see Attachment A for site total details regarding meal count errors.

Corrective Action (s): The sponsor must send FNW a written corrective action plan and supporting documentation for each finding, as well as corresponding dates of completion. The plan must include reasonable timeframes for the sponsor to achieve and maintain program compliance. The \$100.00 threshold was not exceeded; therefore, the sponsor is not required to submit a revised claim for the month of review. Please contact your program representative to request additional assistance with training and corrective action plan development. The FNW program specialists are available to assist with sponsor- and site-level training on-site.



The Florida Department of Agriculture and Consumer Services must receive the corrective action plan as stated above within 30 days from the date of receipt of this notice. Please email your corrective action to programreviews@freshfromflorida.com.
