

Louisville Municipal School District Safe Return to School Plan

2022-2023

Introduction

- Louisville Municipal School District's safe return to school plan for the 2022-2023 has been developed based on MSDH and MDE guidance in accordance with CDC considerations.
- Should guidance from any of the above agencies change, LMSD will make adjustments to this plan.
- LMSD will regularly review this plan and seek input from all stakeholders concerning the plan.

Academic Programming

- LMSD will provide full in person learning for the 22-23 school year.
- LMSD will continue to provide a comprehensive program for all students which includes content area classes, electives, intervention services, enrichment classes, and tutoring.
- LMSD is prepared for a smooth transition to virtual learning should the need arise due to a health-related outbreak. Each student in K-12 will be provided with a technology device. Students will receive instruction and assignments daily.

Academic Programming cont.

- Early diagnostic screenings and periodic benchmark assessments will be conducted and used to make instructional decisions.
- Student progress will be monitored throughout the school year. Data such as benchmark assessment scores, state assessment scores, class grades/test scores, and teacher observations will be used to monitor progress.
- Baseline data will be reviewed and students who have learning gaps will be referred to the MTSS (Multi Tiered System of Supports) Team. Timely and effective interventions will be provided.
- LMSD's school administration will continue to provide staff observation and feedback to ensure effective instruction for students.
- Feedback from staff concerning instructional programming and supports will be gathered through surveys.

Operations

- LMSD will return to the traditional arrival and dismissal procedures for the 22-23 school year.
- Students who arrive/leave on a district school bus will unload/load at the designated area at their school.
- Bus riders will enter the building at the appropriate designated entrance.
- Students who arrive/leave by a private vehicle will unload/load at the designated area for car riders at their school.
- Car riders will enter the building at the appropriate designated entrance.

Operations cont.

- LMSD will continue to provide transportation for students who reside within our school district.
- All buses will be sanitized daily.
- Face masks are recommended on buses.
- Hand sanitizing stations will be available on buses.
- Breakfast and lunch will be provided at each school.

Operations cont.

- Alternate plans for providing meals to students will include eating meals in the cafeteria, taking meals from the cafeteria to the classroom, and/or having meals delivered from the cafeteria to the classrooms, if necessary based on COVID numbers.
- LMSD will operate on a traditional calendar for the 22-23 school year which will consist of 180 instructional days.
- Students will begin school on August 4, 2022.
- The last day of school will be May 25, 2023.
- The 22-23 school calendar is located on the district website.

Family and Community Support

- LMSD schools will host Open House meetings at school throughout the school year.
- Teachers will be available during planning periods for parent/teacher conferences.
- Title I parent and family engagement activities will be provided as academic support to families.
- The Family Center, located on Fair Elementary's campus will continue to provide support for families.
- Families will be included in the MTSS/intervention process.
- Parent Surveys will be used to gather feedback concerning instructional programming and supports.

Communications

- All news and information will be available on LMSD's website, as well as on social media sites such as Twitter.
- LMSD will utilize AIMS or School Status for mass communication with parents.

Health and Safety

- LMSD will follow quarantine guidance from CDC and MSDH.
- Masks are recommended indoors.
- LMSD will provide support in the areas of social, emotional, mental health so that the needs of students and staff are met.
- Current ventilation systems will be maintained to ensure they operate properly and maximize air circulation.

- It is highly recommended that families screen their child(ren) for healthrelated symptoms each morning. Students with temperature of 100.4 degrees are greater can not return to school until fever/system free for 24 hours without fever reducing medicine.
- Routine temperature screenings will not take place; however, should a student have a fever while at school, they will be isolated from the general population and will be required to wear a mask. A parent/guardian will be called to pick up their child and they will not be allowed to return to school until they are fever free for 24 hours without medication.

Buildings:

- Cleaning and sanitizing will be ongoing each day.
- Hand sanitizer dispensers will be located at all building entryways and various points throughout hallways.
- Water bottle filling stations are located throughout the schools.
- Students are encouraged to bring their own water bottles.

Classrooms:

- Classrooms will be cleaned and sanitized daily.
- Hand sanitizer will be provided in every classroom.
- Students will be spaced as far apart from each other as possible. Restrooms:
- Hand sanitizer dispensers will be placed in the bathrooms.
- Bathrooms will be cleaned twice a day or more if needed.

Cafeterias:

- Hand sanitizer dispensers will be located in each cafeteria.
- Cafeterias will be cleaned and sanitized daily.
- Students will be social distanced as much as possible.

Transportation:

- All buses will be cleaned and sanifized daily.
- Hand sanitizing dispensers will be located on each bus.

Extracurricular areas:

- Gyms and other athletic buildings will be cleaned and sanitized daily.
- Athletic equipment will be cleaned and sanitized on a regular basis after use.
- The LMSD Health Clinic, located on the Fair Elementary Campus, will be open to all students of the school district from 7:30 am to 3:30 pm.

 LMSD takes the safety of staff, students, and spectators at extracurricular events seriously. Social distancing will be encouraged when possible. Quarantine guidelines will be followed in order to prevent the spread of Covid 19 at school events. Hand sanitizer dispensers will be located in buildings where extracurricular events take place.

Technology

- LMSD will provide a reliable technology device for each K-12 student for virtual instruction if needed.
- Wifi will be provided that extends to a parking lot at each school.
- Google Classroom will be utilized for both face-to-face instruction and virtual instruction if needed.
- Virtual learning days include actual teaching for a minimum of 330- minutes, as state law requires.

Miscellaneous

- Nonessential visitors and volunteers will be limited.
- Visitors will only be allowed in an office area or a room designated by the school principal.
- Parent/Teacher conferences may be held by phone call, Zoom, FaceTime, etc. if desired.
- Parents/guardians will not be allowed into the school building to walk students to class.
- If there is an outbreak of Covid-19 cases at one time, the choice may be made to quarantine a class or school. Deep cleaning will take place during this time. Students who are affected by the closure will transition to virtual learning.
