4-C) Guests: Chandra Morman from Farmers Union Insurance discussed the current insurance policy held by the Glen Ullin School District. Shawn Dziuk moved, seconded by, Matt Miller to continue the policy with the same coverage that the district has held. Motion unanimously carried.

- **4-D)** Superintendent and Elementary Principal:
- 1. Review of classified handbooks: The handbooks for staff and students continue to be evaluated to further promote the goals of the district with regards to promoting a successful learning environment. A meeting will be set to have the committee review and discuss any changes.
- 2. Covid-19 Action Plan: At this time the district is awaiting Governor Burgum's directives, a response team is being formed at the school. Marie Bittner and Travis Thomas volunteered to be part of this collaboration. Matt Miller will serve as an alternative.
- **4-E)** Secondary Principal/AD: Mr. Barry gave an update to the board on the smart boards needed to be purchased for the high school. Permission was given to move line items that have excess funds in the budget to make this purchase.

5. UNFINISHED BUSINESS:

- **5-A)** Facility Update: Mr. Barry gave a report on the gym floor. It was completed the 28th of June. Sanitation is an ongoing process. The janitors continue to be cleaning the school and working on summer projects.
- **5-B) Staffing for 2020-2021:** A motion was made by Carrie Gerving, seconded by, Travis Thomas to approve to hire Isaiah Krebs as the seventh-twelfth grade math teacher for the 2020-2021 school years. Motion unanimously carried.
- **5-C) Co-op Meeting:** Mr. Barry gave an update to the board that the meeting will take place in Hebron on August 12th, at 5:30pm. The Glen Ullin school board meeting will follow at 8:00 pm, in the Glen Ullin School library.
- **5-D) School Handbooks:** Mr. Barry is working on 2 separate handbooks. One handbook would be designed for the elementary and a separate handbook for the high school. A meeting will be scheduled with the policy committee to go over these handbooks and address any questions.
- **5-E) Finance update:** The business manager, Christine Lawson presented the financial update along with Mr. Barry for the year end 2019-2020 budget and the projected 2020-2021 budget.
- **5-F) Transportation:** Marie Bittner made a motion seconded by Carrie Gerving; Shawn Dziuk abstained from voting to have the vans transmission fixed at Zuroff's repair in Hebron. The need for a new bus was also discussed but no formal decisions were made.
- **5-G) Review Of School Insurance:** This topic occurred under guest.
- **5-H) Board Review Of Fees And Extra-Curricular Activities**: Mr. Barry spoke about lunch prices and where the school district prices fall within the neighborhood schools. Marie Bittner made a motion seconded by Carrie Gerving to keep the lunch prices the same for the 2020-2021 school year unless the state mandates any changes.

5-I)Summer School and Summer Blast Status: Ms. Fittnerer is conducting the second session of Summer Blast with assistance from Klarissa Glasser. The second session of summer school will be hosted by Ms. Fitterer and Mrs. Tibor.

- **6-C) FFA:** Zach Krein continues to pursue opportunities for the club to participate in. They continue to practice for events whether they are ultimately held in person or virtually.
- **6-D) Election of Officers:** Christine Lawson called for Board President Nominations from the floor. Shawn Dziuk nominated Matt Kuhn for Board President. After three calls for other nominations, Travis Thomas made a motion seconded by, Marie Bittner to cease nominations and cast a unanimous vote for Matt Kuhn as School Board President for the 2020-2021 fiscal year. Motion unanimously carried.
