## **COAT Presentation**

Rita Walker with the Community Outreach of Archdale-Trinity invited the board to participate in a poverty workshop scheduled for January 17 from 5:30 p.m. until 8 p.m. The Community Outreach center began in 2003 by providing a food pantry, clothes closet, and thrift store for the Archdale-Trinity area. Ms. Walker said that the organization is sponsoring this workshop to provide information to the community about the critical needs of low-income families.

#### **ESL and Migrant Education Presentation**

Dr. Lynette Graves, Middle School Director, introduced Roxanne Taylor, Recruiter, and Bonnie Edwards, who presented information on the ESL and Migrant Education program. The Migrant Education Program is a federal program with a goal to ensure that all migrant students graduate with a high school diploma (or complete a GED). It provides supplemental services to migrant students to help them overcome education disruption, cultural and language barriers, social isolation, health problems, and other factors of their mobile lifestyle. ESL is a label for students who are learning English, regardless of their lifestyle or ethnicity.

### Alternative Learning School

Director of SIMS/Student Services Sherri Trotter reported that she and Todd Henderson had been planning for an alternative school. Randleman High School, which has the highest dropout rate and largest number of long-term suspensions of any school in the county, has agreed to pilot an alternative learning program. Youth Unlimited has agreed to provide a safe, orderly place for the intervention center, which will teach interpersonal skills to non-violent, non-felonious students. Youth Unlimited will provide behavioral specialists to serve 10-12 students next semester.

# Summer School

Assistant Superintendent Pat Foust shared plans for the 2008 Summer Academy for grades 3<sup>rd</sup>, 5<sup>th</sup>, 8<sup>th</sup>, and 9-12. Bus transportation will be provided June 16-27, 2008, for focused intervention for students in each quadrant not scoring proficient. Quality teachers will be hired for a ratio of 1 to 10-15 students.

## School Improvement Plans

Pat Foust and Dr. Sharon Johnson, Director of Testing and Accountability, presented School Improvement Plans for review. Plans for Ramseur and Southmont are not included. These plans will be submitted to a Peer Review Committee. The plans are designed to address AYP targets and NCLB mandates.

## Safe School Plans

Director of SIMS/Student Services Sherri Trotter reported that all 29 schools had developed safe school plans in compliance with General Statutes and that the plans were available for review.

## Providence Grove High School Update

Providence Grove High School Principal Rick Dawes reported that student rosters were being sent to Randleman Middle, Northeastern Randolph Middle, Southeastern Randolph Middle, Randleman High School, and Eastern Randolph High School and that early registration would begin by the first week in January. A registration night will be held for students attending the new school. Furniture orders will be submitted in December. There will be 11 games in the football schedule; five will be non-conference games. He shared information on logos that were being considered.

## **Energy Conservation Guidelines**

Assistant Superintendent Marty Trotter reviewed Energy Conservation Guidelines for individual classrooms with the Board. Temperature points for classrooms are not changed by these new guidelines. Mr. Trotter also shared the results of an after-hour audit for the schools. Some concerns addressed were computer labs where computers remained up and running during a weekend and how blinds set appropriately could reduce energy costs.

#### Facilities and Construction Update

Assistant Superintendent Marty Trotter provided information and photographs on construction at Providence Grove and Wheatmore High Schools. Both projects are on schedule.

Mr. Trotter also reported that plans are underway for air conditioning of high school gyms and lobbies.

Mr. Trotter stated that he had received a request from Randleman Enrichment Center for a 30 foot sewer easement on the Randleman Elementary School campus. B. Coltrane made a motion seconded by G. Lawson that Superintendent Donald Andrews, Attorney Bob Wilhoit, and Assistant Superintendent Marty Trotter negotiate for the easement as requested. The motion carried: 7-0.

#### **Closed Session**

B. Coltrane made a motion seconded by T. McDonald that the Board go into closed session to discuss the conferring of an honorary degree, scholarship, prize or similar award as provided in North Carolina General Statue 143.318.11(a)(2), discussing the terms of an employment contract as provided in North Carolina General Statute 143.318.11.(a)(5), and considering a personnel matter that involves an officer or employee of this board as provided in North Carolina General Statute 143.318.11(a)(6). The motion carried: 7-0.
