JOINTLY DEVELOPED

The parents, students, and staff of Tattall County High School partnered together to develop this school-parent compact for achievement. Teachers suggested home learning strategies, parents added input about the types of support they needed, and students told us what would help them learn. Parents are encouraged to attend annual revision meetings held during the spring of each year to review the compact and make suggestions based on student needs and school improvement goals. Tattall County School District's GOALS:

More individualized and small group instruction will be implemented in order to meet the needs of all learners to show a 3% increase in the total percentage of students earning levels 2, 3, and 4 on the Spring 2024 GMAS (EOG and EOC) for all content areas.

Tattall County will decrease the percentage of office discipline referrals (ODR) of the top 10% of referred students from 33% in 2022-2023 to 30% of all referrals in the 2023-2024 school year.

Tattall County High School's GOALS:

Tattall County High School will use supplemental learning opportunities to decrease the retention rate of 9th graders from 11% to 9% or better.

Tattall County High School will integrate school-wide literacy strategies to increase the number of proficient and distinguished students by 3% or better on the End of Course assessment in all tested areas for the 2023-2024 school year.

Provide reasonable access to staff and be available for parent-teacher conferences when requested by a parent and use the opportunity to discuss this compact as it relates to the child's academic achievement.

Provide parents with frequent reports on their child's progress through the Parent Portal, grade reports or progress reports, Remind, phone calls, emails, notes, etc.

Provide opportunities for parent to volunteer, participate, or observe various activities.
