Violations Comments

Violation #21. Hot holding temperatures

BBQ chicken was observed at 130 degrees F. The only other available food was fried potatoes, and these were observed at 131 degrees F. This was likely due to the warmer doors opening at random. Staff stated that the doors were broken. It was asked that the food not be served and that the other warmers that were not broken be used instead until the broken units are repaired.

CODE REFERENCE: 64E-11.003(2). PHF/TCS foods, which are held hot and not subject to an approved HACCP plan, must be maintained at 135°F.

Violation #47. Food & non-food contact surfaces

A mold like substance was observed on the shield in the ice machine. The machine must be emptied then cleaned and sanitized.

Two shelves in the walk in refrigerator were observed to be falling these must be repaired or replaced.

CODE REFERENCE: 64E-11.003(4). Equipment and utensils must be properly designed, constructed, and in good repair.

General Comments

A salad in the cold holding area in the cafeteria was observed at 35.1 degrees F. The refrigerating units are working properly.
