We are aware of social media posts encouraging student walkouts. Lake Wales Charter Schools System respects students' rights to express their views in lawful, peaceful ways. At the same time, we have a responsibility to maintain safe campuses and protect instructional time. Walkouts or demonstrations during the school day that require students to leave class, assigned areas, or campus are not permitted and will be addressed under standard attendance and discipline policies.

Students who wish to share concerns are asked to do so in ways that do not disrupt learning—e.g., respectful dialogue with school administration, submitting written concerns, participating in approved student forums, or expressing views outside of school hours and off campus.


