#### Consent for Participation ~ Student Drug Testing

I understand that submission to testing for the presence of drugs and alcohol is a condition of participation in privileged activities in the Carroll County School system. I further understand that if I refuse to be tested, fail to report for the test, or if the test establishes a violation of the drug testing policy, I will be subject to the consequences as set forth by the drug testing policy.

By signing and dating this form, I consent to be randomly tested throughout the school year. The random testing will be done monthly throughout the school year. The selection process for random drug testing will be performed by a contracting body with the participating students being notified the day they are to report for testing.

I hereby consent to the administration of drug tests and to the conditions listed in this consent and the accompanying general prohibitions and procedures as outlined in Policy JCABB, JCABB-R (1) of the Carroll County School System Policy Manual.

I understand that unless my parent or guardian contacts the Drug Testing Administrator after the first year, and makes a formal request to remove, by name and student ID number from the testing pool, my name will be automatically reentered into the testing pool each year.

## Central High School

### Parking Regulations 2025-2026 School Year

A cars will be ticketed and/or towed at the owners' expenses for violation of parking regulations. Parking is a privilege that may be revoked without a refund for parking violations. Vehicles parked within 1000 feet of school property are subject to search.

- 1. Vehicles on campus of Central High School must have a 2024-2025 Central High School hang tag hanging from the rear view mirror and must be in a marked parking space.
- 2. Once a student drives on campus, he/she is considered "at school" and must check out legally in Student Services to leave campus again.
- 3. Students may not loiter (hang-out) in the parking lot before or after school. Students must exit their vehicles and report to the school building <u>immediately</u> upon arrival to school.
- 4. For afternoon dismissal all student drivers must turn right out of the parking lot.
- 5. Dream Team spaces are marked with a DT in front of the number. All other parking is first come first serve.
- 6. Any student vehicle parked anywhere on campus other than the student parking lot will likely be TOWED and parking privileges REVOKED.
- 7. Radios and sound systems must be kept at a volume that cannot be heard outside of the vehicle within 1000 feet of the Central High School campus.
- 8. Students will not be allowed to go to the student parking lot during the school day to get items left in the car.
- 9. Students may not be on your cell phone while driving in the student parking lot.
- 10. Students will be allowed to drive to CCA for 3rd/4th periods only and only if the student is in the Work-Based Learning Program and drives to his/her work immediately after CCA classes. These students must obtain permission from an Assistant Principal at Central High School and the Principal of CCA. All other CCA students must ride the bus to and from CCA. Students may not transport other students to the CCA for any reason.
- 11. Students/Parents will not be allowed to park or drop off in the mornings or pick up in the afternoons in the 400 hall parking lot.
- 12. Permits <u>may not</u> be transferred to other students. Any student who allows someone else to use their hang tag will lose their parking privilege for the remainder of the school year. Parking hang tags cannot be shared!
- 13. Student drivers must complete a Drug Consent Form to be allowed to park on campus.

\*\*\*NEW STATE LAW: Requires that CHS report to the DMV any student who accumulates 10 or more unexcused absences in the current school year or in the previous academic year. Driving privileges of those students will be revoked by the DMV and by Central High School.

2024-2025 Student Parking Regulations Continued:

Students must operate their vehicles in a safe and proper manner at all times on ANY Carroll County School campus.

The following are parking privilege information, rules, regulations and procedures.

#### **DISCIPLINARY ACTIONS:**

- 1. As the result of the first in-school and/or out-of-school suspension, the student parking privileges are suspended for one week.
- 2. Second ISS and/or OSS infraction and parking privileges are revoked for the remainder of the year.
- 3. Substance abuse on campus and parking privileges are revoked for one year in addition to Discipline Code Policy.
- 4. If a weapon is found on the student or in the vehicle, parking privileges are revoked for at least one year with the possibility of permanent revocation in addition to Discipline Code Policy.
- 5. On campus driving misconduct (scratching off, speeding wheelies, etc.) can result in revocation of parking privileges for up to one year.
- 6. Leaving campus without permission will result in parking privileges being revoked for one year.
- 7. Transporting another student off campus without authorization will result in revocation of parking privileges for one year.
- 8. Failure to register a vehicle with the school or improperly parking a vehicle (such as parking in an unassigned space) can result in not only revocation of parking privileges, but also having your car towed away at the owner's expense.

# Parking Consequences for Unexcused Tardies to School

1st Tardy – Warning, student issued a copy of the warning.

2nd Tardy – Probation, student issued warning that future tardies will result in loss of parking privileges.

3rd Tardy – Loss of parking privileges for five (5) school days. The student must surrender the parking permit hang tag to the Main Office.

4th Tardy – Loss of parking privileges for 20 school days. The student must surrender the parking permit hang tag to the Main office upon check-in.

5th Tardy – Loss of parking privileges for remainder of the semester. The student must surrender the parking permit hang tag to the Main Office upon check-in.

\*\*\*Any student who parks on campus after a 5th unexcused tardy to school will have his/her car towed at his/her expense **without** warning.\*\*\*
