Discussion held. All in favor. Motion carried.

9j: VanHuysen moved to approve the Board goals for the 2022-23 school year as amended to include the addition of getting student representatives involved and setting up a class representative to attend Board meetings, supported by Burtch. Discussion held. All in favor. Motion carried.

9k: VanHuysen moved to enter closed session at 9:13, at Thrun's request to discuss the pending litigation of Chaskey vs. Onaway Area Community Schools, supported by Benson. Roll call vote; yay: Veal, VanHuysen, Hart, Benson, Burtch, and Porter. All in Favor. Motion carried.

VanHuysen moved to enter open session at 9:41, supported by Benson. All in favor. Motion carried.
