- A. K-6 Principal Report: Mr. Thorud discussed upcoming KinderKamp on August 21 with the numbers in the 54-56 range
- B. 7-12 Principal Report: Mr.Helmen discussed the attendance for the previous year and provided the board with handouts comparing local and like districts. Ms. McNeil shared her plans for the use of Measure 98 money including hiring a school secretary for college and career readiness, hiring an educational assistant for an alternative education program starting 2nd period and going after school, and summer school. The school will be using Odysseyware for the curriculum. The remainder of the money will be used to purchase mobile labs for the online and college center and to fund the high schools Programs of Study including Health, Natural Resources and CTE. With the loss of the school counselor Ms. McNeil has prepared herself by going through every transcript, learning more about the Synergy program. Roxanne Wilcoxen has also moved her office to CMHS. Ms. McNeil also discussed the law class she took this summer. Enrollment projections are up for the high school, and down for the middle school.
