## ACCESS TO DISTRICT'S NETWORK

## TECHNOLOGY EQUIPMENT AGREEMENT

Technology: Users will follow the District's "acceptable use/equipment agreement/policy". Electronic communications, downloaded material and all data stored on any technology resources that access the District's Network, including files deleted from a user's account, may be intercepted, accessed, monitored or searched by district administrators or their designees at any time in the regular course of business. Such access may include, but is not limited to, verifying that users are complying with District policies and rules and investigating potential misconduct. Any such search, access or interception shall comply with all applicable laws.

By authorizing use of the school district system, the school district does not relinquish control over materials on the system or contained in files on the system. Users should expect only limited privacy in the contents of personal files on the school district system.

#### Please read and initial the Usage/Equipment Agreement.

I understand the network is the property of the Climax Springs R-IV School District and is being provided to me based upon the following conditions:

- Use of the school district system is at the user's own risk. The school district is not responsible for the accuracy or quality of any advice or information obtained through or stored on the school district system. The school district will not be responsible for financial obligations arising through unauthorized use of the school district system or the Internet.
- Use of the school district computer system and Internet shall be consistent with school district policies.
- I agree to abide by all local, State, and Federal regulations and policies that govern the use of hardware and software laws including copyright and intellectual property law pertaining to software and information.
- The District reserves the right to monitor all technology activity.
- The school district system has an educational purpose, which includes use of the system for classroom activities, educational research, and professional or career development activities.
- Uses which might be acceptable on a user's private personal account on another system may not be acceptable on this limited-purpose network.
- Access to network services is given to students who agree to act in a responsible manner.
- Parent/guardian permission is required.
- Access is a privilege, not a right. Therefore, based upon the acceptable use guidelines outlined in this document, the administration and staff will deem what is inappropriate use and their decisions are final.
- Upon identification of inappropriate use of network services by the administration, faculty, and staff, access may be denied, revoked, or suspended at any time.
