Meeting Minutes 7/11/2013

The Governing Board of the Tanque Verde Unified School District #13, Pima County, Tucson, Arizona held a Regular Session on July 11, 2013 in the Board Room, at the Tanque Verde Unified School District Administrative Office, 2300 N.
