Masonry block walls have been completed and the brick veneer is currently underway on the exterior wall elevations. Joist and decking of the lower roof area is nearing completion. The mechanical, electrical and plumbing continue to be roughed in as well.

Administrator Reports Mr. Smith shared information regarding our current school elevator will be replaced due to the age and inability to obtain parts to repair. Bids were received to replace the elevator and awarded to AEL Inc. Over winter break in December there will be masonry work to allow for the new elevator installation, which will hopefully be completed by early January.

Mr. Curtis reported that current high school enrollment is 247 with 93.7% attendance rate. Winter HS sports have started with girls' varsity basketball playing tonight in Hermitage. Varsity boys' and girls' basketball will participate in the Warsaw tournament this next week. JH boys' and girls' basketball have started practicing as well. Saturday December 9th Softball will hold a trivia night here at the school at 6:30PM for their fundraiser, HS Band will march in the Lincoln Christmas parade, and the 2023-2024 Band trip has been scheduled to Orlando FL, for November 24-27, 2024.

Mrs. Eifert reported the elementary enrollment is now at 257 students with an attendance rate of 96%. Reading counts grades 4-6 celebrated tonight with students who have achieved their STAR Reading points. Christmas concerts will be Thursday, December 7th for grades K-3 and Thursday, December 14th for grades 4-6. Youth basketball has started both gyms are busy nightly.
