A number of top ranking colleges and universities which claim to meet 100% of a students' financial need with need-based institutional aid. This means, that if you are accepted into one of the schools below and your family has a low-income level, you most likely will not need to take out loans if the school determines that your family income makes you eligible for full need-based aid. Some students' family incomes may suggest that they can pay for at least some of the fees and tuition for these schools, and the school will still provide money to meet the families partway. For instance, if a school's yearly tuition is \$40,000 per year, and the student can only pay for \$10,000, the school may provide \$30,000 to meet the student partway. In some instances, students may still need to take out student loans. Additionally, students should be aware that while an initial financial-aid package upon a student's admission into a school may not contain student loans, in following years (sophomore—senior years), institutional need-based aid for a student this may decrease, and student loan suggestions may increase.

The good news is that it is not just the Ivy League schools like Harvard University, Stanford University, and Princeton University, which are very competitive and difficult to get accepted into. Still, the following top-ranking schools tend to require higher-than-average scores and G.P.A.'s for acceptance, so it is still important to do your best with academics. In-state tuition scholarships for Arizona universities are available for in-state students with financial need, but this often is dependent on academic performance.

Flinn Scholarship

Requirements/Description:

U.S. citizen or lawful permanent resident (Green Card holder); Be an Arizona resident for two years immediately preceding entry to the university. As a general rule, Flinn Scholarship applicants should: participate and demonstrate leadership in a variety of extracurricular activities; Attain at least a 3.5 GPA (unweighted); Rank in the top 5 percent of their graduating class; Score a minimum 29 on the ACT (composite score), or 1360 on the SAT I (ERW+M).
