 Request by Bledsoe County High Softball Booster Club to discuss/approve a booster funded hitting facility for softball.

Mrs. Jeri Lynn Baker addressed the be Board on behalf of the Bledsoe County High School Softball Booster Club.

She explained that the Softball Booster Club wanted to build a hitting facility similar to the building that was built by the Quarter Back Club. It would be a smaller building. It would be a 60'x40' building. The building would be a pole barn. Cost to the parents would be approximately \$133,000.00 dollars. She stated they were hoping to fund this through fundraisers and donations. The Softball Booster Club is hoping the Board will help with some of the expenses such as guttering, concrete and insulation as was paid for the Quarter Back Club building. This building would be in addition to the concession building that is being built. This buildings location is on the architect's plan and site work. Mr. Boring stated that Mr. Jones should have drawing at the end of the week and would have site work at same time.

Mr. Farmer stated that site work includes paying for professionally stamped drawings for site work related to the practice facility as well as we will pay for any architectural engineering drawings related to structural, mechanical, and electrical on the facility itself. The fabrication company should be able to have those stamped if they are not already stamped, pay for those drawing to be done. Review by Board when stamped and approved. Site work itself, grading, back fill material, packing of materials. We can potentially tie that to the existing contract for the current softball field. Provide a price based on the quantity off of the drawing and bring to the Board as a change order if we wanted to do that.

Ms. Baker is going to email drawing to Mr. Boring to send to Mr. Jones

Motion is for the approval of building and pay for site work, site work drawing, and architectural engineering drawings related to structural, electrical and mechanical.

Paint was paid for from the maintenance budget.

Mr. Boring stated he did not remember approving the expenses for the Quarterback Club building.

Mr. Turner stated since it did not exceed \$10,000.00, that it did not go out to bid and was not brought before the Board.

Mr. Boring asked if it was paid for out of the maintenance budget.

Mr. Turner stated that the gutters that was paid for out of the maintenance budget when they also replaced the field house gutters, but the insulation was paid for out of Capital Projects.

Mr. Boring asked who approved the purchase. Mr. Turner stated it would have just been approved when the purchase order was approved.

Mr. Billingsley stated this was a totally different discussion from this agenda item.

Mr. Turner stated that Mrs. Sparkman requested for future projects to be brought to the Board for any building not built by the board no matter what the expenditure.

Mrs. Sparkman stated that as we are being transparent about other thing we are doing, these things need to be transparent as well. We don't need to do something for one group that we are not willing to do for another and when it comes before the board then everyone knows how we are spending our money.

Concrete estimated to cost \$10,000.00 for concrete labor and materials for a 40'x60' the Board would just be paying for the materials.

Mr. Boring made a motion that if the boosters are paying for the HVAC for the building. I would make a motion that we pay for the other three items out of Capital Projects Funds.

Mr. Snow ask for the motion to be re-read.

Mr. Boring made a motion that the Board will pay for the concrete, insulation and gutters out of Capital Projects.

Mr. Turner is to get quotes on concrete and gutters and Mrs. Sparkman is to approve quotes. The insulation is to go out to bid.

Mr. Boring stated he had a motion and a second for the three items and the insulation going out to bid
