M-to-M Transfer Leaflet K-12

- To qualify, the <u>student's race</u> must be in the <u>majority</u> at the <u>home zoned school</u> and in the <u>minority</u> at the <u>requested school</u>.
- An African American student zoned to a predominantly African American school can be granted a transfer TO a predominately WHITE school only.
- A White student zoned to a predominantly white school can be granted a transfer <u>TO</u> a predominantly African American school only.
- If a child's race is already in the minority at a school, an M-to-M Transfer cannot be granted to any school.
- M to M transfer eligibility is determined by the ethnic ratios at schools as of May 27, 2025 for the 2025-26 school year.
- Once a student is approved, they remain eligible for the entire time they are in that school.
 They do not need to apply annually. However, when they move onto the feeder school, they must reapply.
