Grading Policy KRS 160.345(3)(b)

<u>Purpose:</u> The Grading Policy for Millbrooke Elementary School defines the grading and reporting policies and procedures to ensure academic grades are based on clearly defined criteria representing the student's attainment of content knowledge and skills.

<u>Procedures:</u> Classroom teachers in grades first to sixth are required to enter 2 grades per week into Infinite Campus for no less than 18 grades per quarter. These grades will be based on a combination of classroom work, unit tests, and quizzes. Teachers in the grade level that teach the same subject will work together to ensure students in the grade are receiving the same kinds of grades on the same kinds of assignments. Students in Kindergarten receive grades based on the progress towards skills to be obtained. Special area teachers (music, art, library, PE) teachers will give grades based on participation in their classes every semester. Below is a chart of what kinds of grades are given at each grade level based on board policy. Teachers will maintain detailed, systematic records of the achievement of each student in grade book. Teachers will provide mid-term reports, as well as a report every nine weeks to the parent or guardian on the progress of their child. Teachers will maintain detailed, systematic records regarding missing assignments. Students will be provided opportunities to complete assignments and make up work. The expectation is for all assignments to be completed.

A = 90-100 The student is more than meeting the demands of the teacher. Assignments are completed by due dates, superior in quality, and shows mastery of subject matter. The student has the ability to complete assignments at a distinguished level and has a positive influence on the class.

B = 80-89 The assignments are superior in nature and the required work is well done. The student meets the demands of the teacher, there is evidence of growth and the student exerts a positive influence on the class.

C =70-79 The student completes the work required at a satisfactory level. The assignment is completed by the due date and exhibits average quality. The student demonstrates average evidence of growth.

D = 60-69 The assignment is typically below grade-appropriate level. There is slight evidence of growth.

F= 0-59 The assignment is completed at an unsatisfactory level with little or no evidence of growth.

***The lowest grade in each content area will be dropped at the end of each nine weeks.
