Principal Shannon Soule presented the Governing Board with the End of the Year Report for SY 2022-2023. Discussion was held.

6. Superintendent's Report.

Mrs. Nehrmeyer reported on the following:

 Completion, 8th Grade Promotion, Spring Honors Assemblies, and an End of Year Luncheon hosted by the Oracle Schools Foundation.
- Mt. Vista K-8 School 2023 Teacher of the Year: Christine Maki, 1st Grade Teacher
- Mt. Vista K-8 School 2023 Employee of the Year: Otilia Baeza, Custodian
- Mt. Vista K-8 School 2023 Team of the Year: Transportation Team including Leo Martinez, Ronda Waltermire, Georgina Gaona, Terry Ellis, Elina Gaona, Bobby Altamirano, Misty Chavez, Frank Gallardo, Vicky Sanchez, and Brianna Looney.
- NJHS and Student Council students learned, grew, and developed as school leaders throughout the 2023 Leadership Trip to Los Angeles in May 2023. Students will be invited to share what they learned with the Governing Board when they return to campus in August.
- Chas Brownrigg, Food Service Director has prepared a presentation for the Governing Board which she plans to share during the mid-June regular meeting. This presentation will include positive changes made in the program during the 2022-2023 school year as well as plans for the upcoming school year.

7. Capital Bond Report

Mrs. Nehrmeyer updated the Governing Board on construction progress and key upcoming dates for the following:

- The District cancelled the Punch list walk scheduled for Friday, May 19 (Building N, Library) based on the number of items still in progress. The Punch list walk was rescheduled for Thursday, June 1. This Punch list walk started, but the District quickly discovered many items were incomplete. The District stopped the Punch walk and instructed Chasse Building Team to spend two weeks working on incomplete items and schedule a final Punch list walk for the week of June 12.
- Library furniture was delivered and installed by Arizona Furnishings.
- School Office Lobby is in progress, expected completion date of June 30, 2023.
- Basketball court is in progress, expected completion date by mid-June 2023.
- Southwest Gas is scheduled to come and dig-up the gas line by the new library, install a sleeve that is crucial for the success of the project, and install a new gas meter. This is scheduled for the week of June 5.
- An amendment to the Chasse Building Team and District CMAR Contract was drafted by
 District legal counsel and sent to CBT for review. CBT is pricing the ramp lighting project and
 snow caps to be used with remaining project funds.

8. Sale of Oracle Ridge Property Report

Mrs. Crall and Superintendent Nehrmeyer shared information regarding the sale of the Oracle Ridge property with the Governing Board following the May 2023 Regular Meeting. The information presented included the following subjects:

- Mrs. Crall spoke with a representative from the Oracle Piano Society regarding possible interest in the property.
- An unknown alarm went off at the property on Sunday, May 28. Neighbors called 911, Mrs.
 Nehrmeyer was contacted. Pinal County Sherriff's Department checked the property and
 did not find any new vandalism or trespassing. Mr. Velasquez came to the property and
 silenced the alarm. The property is not currently alarmed or monitored, the District is not
 sure what made an alarm sound.

Mrs. Lyon did ask that the draft of the Governing Board's statement be changed in a few areas. Mrs. Crall moved and Mr. Gotay seconded the approval of the Governing Board's statement as changed, Roll Call Vote: 5 ayes, 0 nays, all in favor and motion carried.
