**Elementary report given by Emily Smith**

## High School Report given by Jess Krulik

Over the past few weeks, our students have demonstrated increased engagement and initiative, both academically and civically. One of the most notable recent developments is the creation of a student-led petition regarding the current dress code policy—specifically, the prohibition of wearing hats within the school building. A group of students have organized themselves to advocate for a revision of this policy, citing personal expression, comfort, and cultural considerations as key reasons for the change. They gathered over 200 signatures and have expressed their desire to work collaboratively with school administration and the Board to explore potential changes. Their respectful approach and willingness to engage in the process reflect positively on the leadership skills we are working to foster in our students and I agreed to bring it to the board for consideration.

Additionally, our Spring EOC (End-of-Course) state testing window is now underway. This past week, both our junior high and high school students completed ELA Part 1 testing. We implemented a two-hour delay on testing days to provide a calm and focused testing environment for students and to allow staff adequate time to administer the assessments and have enough staff to separate the students into smaller groups utilizing many classrooms. We're pleased to report that the delay structure worked very well. Students arrived on time, and the staggered schedule created minimal disruption to the rest of the academic day. Staff feedback was overwhelmingly positive, and we anticipate a similar approach for the upcoming math, science, and social studies testing dates.
