Elementary Principal Amelia Black Bear also addressed the Board with concerns regarding students potentially not receiving adequate food portions during meal service. A discussion followed regarding the school's responsibility to remain in compliance with CACFP/CANS nutritional guidelines.

Business Manager Pedro Rosa noted that the school should review current food service portioning to ensure that meals are meeting required standards.

Superintendent James Bagwell added that the school continues to encourage all students to participate in breakfast and lunch programs and reminded the Board that the school implemented the after-school supper program this year to further support student nutrition.

Board Member Dawn Moves Camp mentioned the instructional program IXL, noting that some schools provide parent access to the platform. She suggested that the school explore the possibility of offering it as a supplemental academic resource for students and families.


