### What is a Title I School?

- Title I, Part A is a federally funded program under the elementary and secondary education act (ESEA) of 1965
- The purpose of Title I under ESEA is to ensure that all children have a fair, equal, and significant opportunity to obtain a high-quality education and succeed on challenging state academic achievement standards and state academic assessments.

## How is Title I funding used?

- To purchase supplemental programs and instructional resources to support student achievement.
- To strengthen family engagement events, workshops, and meetings.
- To provide ongoing professional learning for our teaching and staff.
- To reduce class size by lowering student-teacher ratio.
- To acquire additional resources that enhance instruction.

## What is a Title I schoolwide program?

The purpose of schoolwide Title I programs is to improve the entire educational program in a school which should result in improving the academic achievement of all students, particularly the lowest achieving students.

### Schoolwide Title I Goals

- Goal 1: By June 30th, 2026, JRT will improve the number of students performing at Levels 2, 3, and 4 in ELA and Math by a 3% point gain compared to the state average on the Georgia Milestones Assessment.
- Goal 2: By June 2026, at least 90% of collaborative teams will meet the established operational indicators for year 2 as determined by the District Collaborative Team Action Plan.
- Goal 3: By June 30th, 2026, JRT will decrease the total number of days of instruction missed due to social/emotional/behavioral needs by 5%.
- Goal 4: JRT leadership will implement MTSS functions as outlined by the VCS guidelines.

### 2025- 2026 JR TRIPPE PRIORITIES: AT A GLANCE



#### COLLABORATIVE PLANNING

Teams work interdependently to plan, analyze student learning, and respond to data, using shared goals and protocols to improve outcomes.



#### **TEACHER CLARITY**

Teacher Clarity ensures that students understand what they are learning, why it matters, and what success looks like. It includes clear learning targets, success criteria, and feedback opportunities that help students take ownership of their progress.



#### **LESSON PLANNING**

Lesson plans connect daily learning targets, instructional strategies, and assessments, ensuring access, engagement, and support for all students.



#### UNIT DEVELOPMENT

Teachers collaboratively design units using backward design to align standards, assessments, and instruction for consistent, meaningful learning.



### SPECIALLY DESIGNED INSTRUCTION (SDI)

SDI is individualized instruction for students with disabilities that adapts content, method, or delivery based on their IEP goals and unique learning needs, ensuring access to grade-level curriculum.



#### MTSS (TIER 1)

Tier 1 focuses on strong universal instruction and proactive supports for academics, behavior, and wellbeing for all students, informed by data. Tier 1 ensures a whole child approach.



#### **SEL CURRICULUM**

Teachers implement a Tier 1
Social Emotional Learning
Curriculum, Character Strong,
to proactively address
emotional needs of all
students.



### RESTORATIVE PRACTICES

Restorative practices are strategies that help teachers build strong, respectful relationships with students and create a positive classroom community. They emphasize repairing harm, promoting accountability, and restoring trust when conflicts arise.

- Benchmarks for measuring student progress
  - Dibels Next (Reading)
  - MAP (Reading & Math)

# What are the requirements for Title I, Part A Parent & Family Engagement?

- 1% of the total amount of Title I, Part A funding must be used for Parent and Family Engagement Activities.
- Schools must hold a Title I Annual Meeting prior to November 1st of each year.
- District and School Parent and Family Engagement Policy plans are developed with stakeholder/parent input and available on the school website by November 1<sup>st</sup> of each year.
- Parent-School Compacts are developed with parent input, distributed to stakeholders/parents and students for signatures, and available on the school website by November 1<sup>st</sup>.

  - Because we are a Title I school, we follow federal guidelines (ESEA) that ensure all teachers meet certain requirements.
  - The rules give you an opportunity to learn more about your child's teachers' and paraprofessionals' training and credentials.
- The Right to Know Notification is sent home to all parents at the beginning of the school year and is available on the school website.
