Motion by Terry Bramlett, seconded by Lewis DeWeese, to approve Deborah Decubellis as an Interim Administrator effective January 13, 2020, pending completion of paperwork and background check. All members voted yes; motion carried.

Motion by Bobby Bearden, seconded by Mike Cole, to approve Tonya Burchfield as a substitute teacher pending completion of paperwork and background check. All members voted yes; motion carried.

Superintendent's Comments:

Superintendent Gwatney thanked Mr. DeWeese and Mr. Galloway for their past service as Board Chair and Vice-Chair, and he congratulated the new Chair Chad Galloway and new Vice-Chair Terry Bramlett. He also thanked the Boy Scouts from the Order of the Arrow Chapter for the Mountain District for leading the Pledge and the Invocation.

Superintendent Gwatney stated that the White Christmas programs at the PAC were awesome. He commended those who helped coordinate the programs, including Elden Moates, FCHS, the FCSS Transportation Department, and the elementary schools for organizing the programs. Superintendent Gwatney is thankful for the parents and grandparents who came to enjoy the programs.

Superintendent Gwatney congratulated Principal Alison Danner, and he thanked the WFES SGT members for their hard work with the process. He recognized Betsy Hyde for serving as the Interim Principal of WFES.
