Facilities. Last week, we were able to get a few days of good weather, allowing us to have concrete poured for the new ADA ramp near the high school gymnasium. Handrails will be added shortly, and another area of cracked concrete will be replaced shortly to increase our number of ADA spots in that lot to four. This will make the entry access better for our wonderful community basketball fans. A big thank you to Randall for coordinating this project and to Cheuvorant Concrete for doing the work quickly and at a reasonable price. We also appreciate ABCDE asphalt for donating updates to the ADA labels in the lot near this new ramp.



Music Program. If you have attended recent home basketball games, you probably noticed that the Pep Band is a new addition to the event. Thank you to the musicians and Mr. Hughston for their work preparing for the games and adding a fun new element to the Logger experience. The band will be holding a concert at the Liberty Theater in Astoria on March 17th. This is a don't miss event!



Drama Performances. The Missoula Children's Theater evening performance will be on March 13th at 6pm. A big thank you to Carrie Palenske for leading this experience, Liz Jolley for providing accompaniment, and to Knappa Schools Foundation for supporting MCT each year. The Drama Club is busy preparing for their spring performances of "Art Attack" which will occur on May 2 (7pm) and May 3 (2pm) at Ten-Fifteen Theater in Astoria. Professional Development. Our professional development series for our teaching staff continued last Monday with time spent on "thinking routines" which are strategies that can be used in any classroom to increase students' thinking demand, improve engagement, and improve literacy skills. Each teacher chose several of these strategies to implement in their classrooms to help our students achieve.

Additionally, the team focused on improving district literacy approaches with strategic work regarding balance of core curriculum and supplements, consistency of the reading block, how to increase writing experiences for students, and layering comprehension strategies for secondary content teachers. We also are developing structures to provide dedicated ELA instruction in the middle school.

We wish to thank Astoria Safeway for donating food for the event, Coffee Girl for providing a discount on coffee, and the Holcom family for their deep discount on the meeting venue on Pier 39.

Principal Isom provided great facilitation for our afternoon session and NWRESD provided quality leadership for the morning session. Our PD leadership team includes Emma Mullins, Wendy Montgomery, Maddy Buoy, Henry Samuelson, Brittany Norton, and Carrie Palenske. Dr. Rynberg was also instrumental in helping provide scaffolding for this event.



Astoria-Warrenton Chamber of Commerce After Hours Event. On March 12th, Knappa School District will host the Chamber of Commerce After Hours event. These monthly events are hosted by Chamber members and highlight their business and the good things they do. School Board Report

Recently our school has managed to accomplish many things. A couple weeks ago we held an assembly for the kindergarten through 8th graders about the American Heart Association and a Tsunami Skippers performance. The Tsunami Skippers, which is a jumproping team, were able to come due to the Student Council's fundraising, as was a member from the American Heart Association. Before the Tsunami Skippers performed, a member from the American Heart Association gave us information about how to keep a healthy heart, and about the American Heart Challenge. The American Heart Challenge is a way to raise awareness for children with heart problems, and the kids participating in it can earn prizes, learn hands only CPR, and raise money for the American Heart Association.

There are multiple acts like singing, dancing, cheerleading, comedy, music, magic, and any other appropriate talents. 

100 GENERAL FUND | Financial Projection by Object





Subject: School Board Report – February 18, 2026

For the past few months, we have been working with the American Heart Association to support heart healthy living with students. As a part of this effort, I had our student council work in tandem to support heart health with this organization. Recently, K-8 students were a part of an assembly to spread awareness for living healthy, maintaining heart health, and the need to support children who might be experiencing heart problems. Students were encouraged and provided an opportunity to get involved with the American Heart Associations “The American Heart Challenge”. The heart challenge raises awareness for children with heart problems, provides trainings for CPR, and raises money to support their cause. To support active living, while having fun, the student council raised funds to have the Tsunami Skippers jump rope team perform for them. It was an excellent opportunity to learn and have fun while doing it. Students that participate in the heart challenge can earn prizes while supporting heart health for all.



A part of our daily efforts are to promote students who are exhibiting excellent character traits. To support this effort, on the last Friday of every month we host a student of the month assembly to promote our focused character trait for the month. Additionally, teachers and staff support each other by recognizing, in the moment, a positive character trait exhibited by a student or staff member that needs called out. Daily, teachers complete a purple referral to acknowledge the good deed or accomplishment. The purple referral is sent to the Principal's office, the Principal provides a comment to support the good deed, and the students or teachers name are mentioned during the morning announcements. Students come to the office to get their purple referral, fun pencil and sticker. Older students are provided a donut. The smiles on their face say it all. Here is one picture of students coming to the office to get their purple referral. The joy in exhibiting a good character trait is reinforced and the smiles and acknowledgment say it all. Thanks goes out to all staff for participating in this daily. Students are so excited to be mentioned for their positive choices.



Lastly, this month our administrative and teacher team met for a full day of professional learning. The training, in tandem with our ESD and professional learning team, provided training to our professional staff to further support our efforts to develop a deeper understanding for teaching and learning, as well as broaden our efforts to have a

cohesive Prek-12 English language program. The staff were provided opportunities to engage effective teaching practices to support making thinking more visible. We also engaged them on the topic of literacy for all. Using data collected from staff input and in person interviews, we determined a need to address five themes that arose from this data collection to further support our direction towards a strong ELA program.
