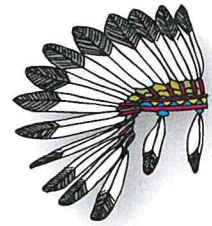

## Parent and Family Engagement Policy 2024-2025 SY


