The board must approve the budget and submit signatures no later than June 20th, 2025.

BAR 585-000-2425-0026-D is a decrease BAR for FUND 11000 OPERATIONAL in the amount of \$54,078.92. Original SEG was \$1,440,535.35 reduced to 1,386,456.43. This Adjustment reflects final unit value, teacher cost index audits, NB certified teaching, save harmless and adjustments to projected membership based on the first reporting period.

BAR 585-000-2425-0027-T is a transfer BAR for FUND 27552-CTE State Wide Innovations, this is to transfer money to other line item expenditures.

Director Report: Director Smith presented his report to the board. He reported on a significant improvement in our attendance. Dual enrollment numbers reported to him by the UNM dual enrollment registrar, Kelsey Mead, are reported to be the highest it's ever been. Work Based learning has 54 students participating. Recruitment update was given to the board regarding the application process. He along with the VGHS Leadership team decided to remove the letter of interest and letter of recommendation as part our enrollment process. We do not want to provide any barriers to students attending VGHS. Director Smith reported on student academic data in reading, math, and language usage analyzing the growth for BOY to MOY data. We have been working with UNM-Taos dual enrollment to align our 2025-26 schedule as much as possible in order to open up different dual enrollment options for students. Signage with our school policy regarding "outside food" presented at the last meeting, was placed in the Cafeteria for students to review. He reported on our "student voice" document, formal VGHS leadership team meetings, and other upcoming events.
