Session I

Mr. Andrews, Superintendent

Reviewed the work session agenda. Mr. Andrews introduced Ms. Hillary Spangler, a student at North Carolina State University to give a presentation to the Board.

Hillary Spangler

- NCSU Junior majoring in Biology and Nutrition
- Created a program called Think F.A.S.T. (Find. Ask. Select. Taste) focusing on teaching children to have healthy eating choices.
- The program is designed for 3rd grade students
- March 2012 National Nutrition Month
- This program will be a collaboration with the Superintendent's Student Advisory Coalition where students will be teaching students.
- Think F.A.S.T. Choose the best options from a fast food restaurant by choosing the healthier option
- Learning to live an overall healthy lifestyle

Superintendent's Annual Plans for 2011-2012

- Areas of emphasis: Essential standards and common core, technology, data analysis (data room), evaluation of staff, legislative mandates, budget forecast for 2012-2013, bullying, customer service (internal and external) – how we respond to parents, and community.

 young people learn and accept knowledge is totally different. Principals/Lead Teachers need to
 follow through to help teachers adjust. Administration to be more active in the classrooms.
 Discussed observations formally and informally. Mr. Andrews expressed the need of more
 awareness in the way we teach and present information.
