

INTERDISTRICT COOPERATIVE AGREEMENT FOR BOYS SOCCER PROGRAM

Between Clatskanie School District and Rainier School District

2026-2027 School Year

This Interdistrict Cooperative Agreement (“Agreement”) is entered into by and between **Clatskanie School District** (“Clatskanie”) and **Rainier School District** (“Rainier”), collectively referred to as the “Districts,” for the purpose of establishing a cooperative high school boys soccer program for the 2026–2027 school year.

1. Purpose

The purpose of this Agreement is to provide an interscholastic boys soccer program through a cooperative arrangement that allows eligible students from Clatskanie High School and Rainier High School to participate while clearly defining the responsibilities of each district.

2. Practice and Game Locations

- All team practices will be held at Clatskanie City Park unless otherwise agreed upon by both districts.
- Home contests will be hosted at both Clatskanie and Rainier facilities according to a mutually agreed-upon schedule.

3. Transportation

A. Game Transportation

- For games departing from Clatskanie, the team bus will leave from the back parking lot of Clatskanie Middle/High School (CMHS). Rainier student-athletes must be transported to CMHS by a parent/guardian or Rainier coaching staff.
- For games departing from Rainier, the team bus will leave from Rainier Junior/Senior High School (RHS). Clatskanie student-athletes must be transported to RHS by a parent/guardian or Clatskanie coaching staff.
- When feasible, and upon mutual agreement by both districts, the team bus may stop at an agreed-upon pickup/drop-off location near Rainier (e.g., “Airlock”).

B. Practice Transportation

- Rainier School District shall provide transportation for Rainier student-athletes to practices and games held in Clatskanie through the use of an activity bus and/or district-approved transportation arrangements.

4. Financial Responsibilities

A. Clatskanie School District Responsibilities

Clatskanie School District shall cover the following expenses for the cooperative boys soccer program:

- Supplies
- Uniforms

B. Shared Financial Responsibilities

Clatskanie and Rainier School District shall equally share the following expenses:

1. Varsity head coach salary, using Clatskanie's coaching salary schedule
2. Officials' fees
 - Clatskanie shall pay officials for contests hosted in Clatskanie.
 - Rainier shall pay officials for contests hosted in Rainier.
3. Transportation costs
 - Clatskanie shall provide and pay for transportation for away contests during the first half of the season.
 - Rainier shall provide and pay for transportation for away contests during the second half of the season.

5. Supervision and Event Management

- Rainier School District shall be responsible for supervision and event management for contests hosted at Rainier facilities.
- Clatskanie School District shall be responsible for supervision and event management for contests hosted at Clatskanie facilities.

6. School of Record and OSAA Responsibilities

Clatskanie School District shall serve as the official school of record with the Oregon School Activities Association.

Clatskanie shall be responsible for:

1. Maintaining team rosters and schedules on the OSAA website
2. Reporting scores and contest results
3. Managing official OSAA correspondence and compliance requirements

7. Student Records and Eligibility

- Each district shall maintain registration, academic records, attendance records, and eligibility monitoring for its own students.
- Each district shall promptly notify Clatskanie, as the school of record, of any eligibility concerns involving its student-athletes.

8. ASB Fundraising and Expenditures

- All Associated Student Body (ASB) fundraising activities and expenditures related to the boys soccer program shall comply with all applicable laws, regulations, and district policies.
- Both districts shall work collaboratively to promote equitable opportunities and support for all participating student-athletes.

9. Term and Termination

- This Agreement shall remain in effect for the 2026–2027 school year.
- Either district may terminate this Agreement with thirty (30) days written notice to the other district.
- Termination shall not relieve either district of financial or contractual obligations incurred prior to the termination date unless otherwise agreed to in writing.
