Of course, with AmeriHealth New Jersey PPO, you have the freedom to select providers who do not participate in the AmeriHealth New Jersey PPO network. However, if you receive services from out-of-network providers, you will have higher out-of-pocket costs and may have to submit your claim for reimbursement.
