This is the largest cut in the revenue. Bridget stated that they will go over this more at the next meeting. David inquired about the generator that ceased up that was at the SAU Office. It was given to the Automotive Class when no other bids came in on it. When the Tech Class could not do anymore with it it was taken to the dump for disposal. David felt that there should have been another advertisement giving it away to someone who may have wanted it. It was pointed out that it cost money and time to advertise for something that appears no one wants.

Policy GBEB - It was requested that policy GBEB come back to the board. Dana explained that there are two copies of this policy and reviewed the adoption dates of this policy. # **Broadcasting Student Activity Account Amendment**

We are seeking approval to amend the previously approved request for the Broadcasting Student Activity Account, which was approved on April 2, 2024.

The initial request for the account was to accept donations, hold funds, and use those funds to replace broadcasting equipment as needed. These donations covered the full cost of acquiring all required equipment during the first year of the program. With that equipment now fully purchased, we would like to adjust the official plan for the use of donations moving forward.

## The revised proposal:

This account is to accept donations, hold funds, and use funds to purchase broadcasting equipment when needed, secure contracted services that will aid in growth of the program, and that total donations in excess of \$3,000 be directed to supporting other school departments to enhance their programs, including, but not limited to the athletic department.

This change reflects the understanding that the major broadcasting equipment has a lifespan of at least five years, so the need for ongoing large-scale equipment purchases will be minimal. Additionally, the athletic department is our primary source of broadcast material, and this model mirrors the approach used by other streaming providers in the past, but with more funds benefiting both our broadcasting students and athletes.

This was the original plan, although not explicitly stated in the initial request. We believe this adjustment will better support both the broadcasting and athletic programs, while ensuring the sustainability of the Broadcasting Student Activity Account.

We appreciate your consideration of this request, Tyler Snyder and the Broadcasting Club

### **Examples of non-equipment purchases:**

- 1. Purchase warm up tops for 3rd-8th graders to give our younger athletes, who work hard and represent Colebrook, a sense of community and support. These athletes are ~92% of our viewership.
- 2. Secure broadcasting services from local professionals to enhance our program and the growth of the club through their platform.
