### Administration

#### 2013-2014 Preliminary Budget

Mr. Todd Lowe presented and reviewed the 2013-2014 Preliminary Budget. In review there were concerns expressed regarding the instructional supply allotment and how it was spent at the individual school sites. There were also concerns of getting information out to stakeholders regarding funding that had been requested from County Commissioners toward the facility plan for Braxton Craven Middle School in the Archdale-Trinity area. The policy will be brought back to the Board for a second reading and approval at the May 20, 2013 Board of Education meeting.
