

**Illinois Instructional Mandates 2022-23**  
(Formerly Illinois Mandated Units of Study)

Below you will find listed areas of study that are mandated by the Illinois School Code and the Illinois Administrative Code. Statutory and regulatory references are included, as appropriate, and should be reviewed carefully to ensure that schools are meeting all requirements. **New requirements beginning with the 2022-23 school year are highlighted in yellow.**
