Items for Information and Discussion

A. NMHS Update

Belfor Property Restoration is still conducting the removal and replacement of casework in the New Milford High School classrooms. This casework consists of cabinets and countertops. Several dozen rooms, including the science labs will be addressed. This work is taking place during the second shift, after school hours. As of this writing the first and second floor classrooms are complete. By the end of spring break it is anticipated that all rooms will have cabinetry completed and they will be awaiting the arrival of the epoxy countertops for the science labs.

Roofing contractor Greenwood Industries continues to work on the standing seam metal roof. The core of the building is completed. They are now working on the four corner turrets and their lower roofs to address. After those are completed and trim work like snow rails installed, the roofers will move onto the low sloped roofs which require flashing then flood and gravel. Weekly meetings are held discussing what areas are being worked on to coordinate with parking and entrance accessibility. During drop off and pick up no equipment is moved in order to avoid interfering with the arrival and dismissal process. No final timetable for the overall completion of this project has been submitted as of this writing.

B. NV5/ESG Update

ESG has completed the physical installation of solar panels on Hill and Plain school. They are conducting a shutdown of the building on 3/11. This will enable them to make the electrical connections allowing this electricity to feed back into the power grid. Subcontractor Vanguard has begun the installation of solar panels on Sarah Noble School which is 50% complete. This overall solar project should be completed by late Spring depending on the equipment supply chain.

C. Central Offices

Silver Petrucelli has been contracted to supply conceptual drawings and cost estimates for the construction of permanent Administrative office space at Sarah Noble. This stage will provide the Board of Education with the scope of the construction work and the price tag for the anticipated construction project.

D. Security Grant

The State of Connecticut, Department Of Emergency Services & Public Protection, has made available a grant for various security enhancements. The date for submission has been moved from the end of March to the end of April. The items being considered will be discussed in the Executive Session.

E. NMHS Woodshop HVAC

An RFP for architectural and engineering services for the New Milford High School woodshop code improvements was posted. Bids were opened on February 27, 2023. We received two bids. The lowest bid was submitted by Landmark Facilities Group out of Norwalk, CT. Based on their references, firm experience, and lump sum number, I am recommending moving forward with hiring this company for A&E services relating to the New Milford high School woodshop HVAC upgrades. This will be discussed more in the Operation Sub- Committee.

F. Security Camera Update

The District plans to move forward with security camera improvements throughout the schools beginning with Schaghticoke. This process will be discussed more in the Operation Sub- Committee. Specific details of this project will be discussed in the Executive Session.

G. Fire Marshal's Reports

Included in this subcommittee packet are the full Fire Marshal's reports from both incidents at the New Milford High School , one occurring on December 1, 2022, the other on July 5, 2023.

AREA OF ORIGIN: The area of origin was on the north-east side of the roof, above the wing where the wood shop is located.

FLAME SPREAD: Based on the burn patterns, lines of demarcation, fire damage, and evidence available, the fire started in the cve of the roof and traveled to the plywood under lament.

SPRINKLERS: A sprinkler system was installed in the building, but did not operate due to the fire being on the roof of the building.

EXTERIOR

EXAMINATION:

At approximately 1210 hours on 2/26/2018 this investigation team systematically began an exterior examination of the scene that revealed the following:

North side – No visible damage.

South side – No visible damage.

West side – No visible fire damage.

East side – No visible fire damage.

The only damage was on the roof where the fire occurred.

INTERIOR

EXAMINATION:

At approximately 1340 hours on 12/01/2021, this investigator began an interior examination from the area of least damage to the area of most damage. The entire wing of the wood shop area including several class rooms had a smoke condition. There was a dense haze of smoke and it was removed by the air handlers in that section of the building.

ACTION

TAKEN:

On 12/01/2021 at approximately 1321 hours, this investigator arrived at the aforementioned location to conduct an investigation into the fire that occurred on the roof at New Milford High School. Upon my arrival I met with Captain Sean Delaney and he advised me that they were investigating a fire located on the North East side of the roof. He stated to me that they used a dry powder and a water can fire extinguisher. They were in the process of getting a roof saw and an inch and three quarter hose line up on the roof.

I then spoke to the job site manager Kevin Marino and he stated to me that his workers were replacing the roof on the high school. He stated to me that during their work they were using a propane torch to heat the flashing that they were installing on the roof. Filipe Silva the worker that was using the torch said I went down to use the bathroom around 11:55 am and returned at 12:15 pm and saw smoke coming from under the gutter. Mr. Silva used a dry powder extinguisher and did not see any more smoke. Mr. Silva stated to me that when the wind picked up he

could see white smoke coming from under the gutter, he then tried to open the plywood up and the fire department arrived and took over the suppression activates.

The fire department used an inch and three quarter hose line and used about 500 gallons of water to extinguish the fire.

CONCLUSION:

Based on the available evidence, burn patterns, observations, witness statements. This fire was caused by a propane torch used in the process of applying flashing material to the roof.

North side – No visible fire damage.

South side – No visible fire damage.

West side – No visible fire damage.

East side – No visible fire damage.

There was no fire damage seen from the ground level. There was fire damage on the south side of the roof above the center hallway.

INTERIOR EXAMINATION:

At approximately 1540 hours on 07/05/2022, this investigation team began an interior examination from the area of least damage to the area of most damage. The first, second and third floors all sustained water and smoke damage due to the fire on the roof directly above the room labeled the Greenhouse.

ACTION TAKEN:

On 07/05/2022 at approximately 1308 hours, this investigator arrived at the aforementioned location to conduct an investigation into the fire that occurred on the roof at New Milford High School. Upon my arrival I met with Chief Kurt Elsesser and he advised me that they were trying to find and extinguish a fire that was on the south side of the roof above the center hallway. He stated to me that the firefighters used fire exstingishers to exstinguish the fire at first while they were waiting for more manpower to arrive on scene. As more manpower arrived they were in the process of getting a roof saw and an inch and three quarter hose line up on the roof.

I then spoke to the job site manager Kevin Marino and he stated to me that his workers were replacing the roof on the high school. He stated to me that during their work they were using a propane torch to heat the membraine flashing that they were installing on the roof.

The fire department used several inch and three quarter hose lines to extinguish the fire.

Note: On 12-1-2021 there was a fire on the north east area of the roof that was caused by a torch in the process of the roof being replaced. (Report is on file at the New Milford Fire Marshals Office)

CONCLUSION:

Based on the available evidence, burn patterns, observations and witness statements. This fire was caused by a propane torch used in the process of applying flashing material to the roof.

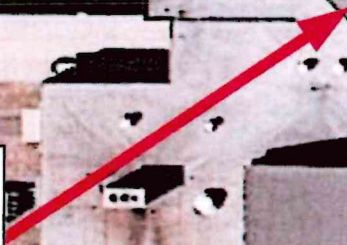

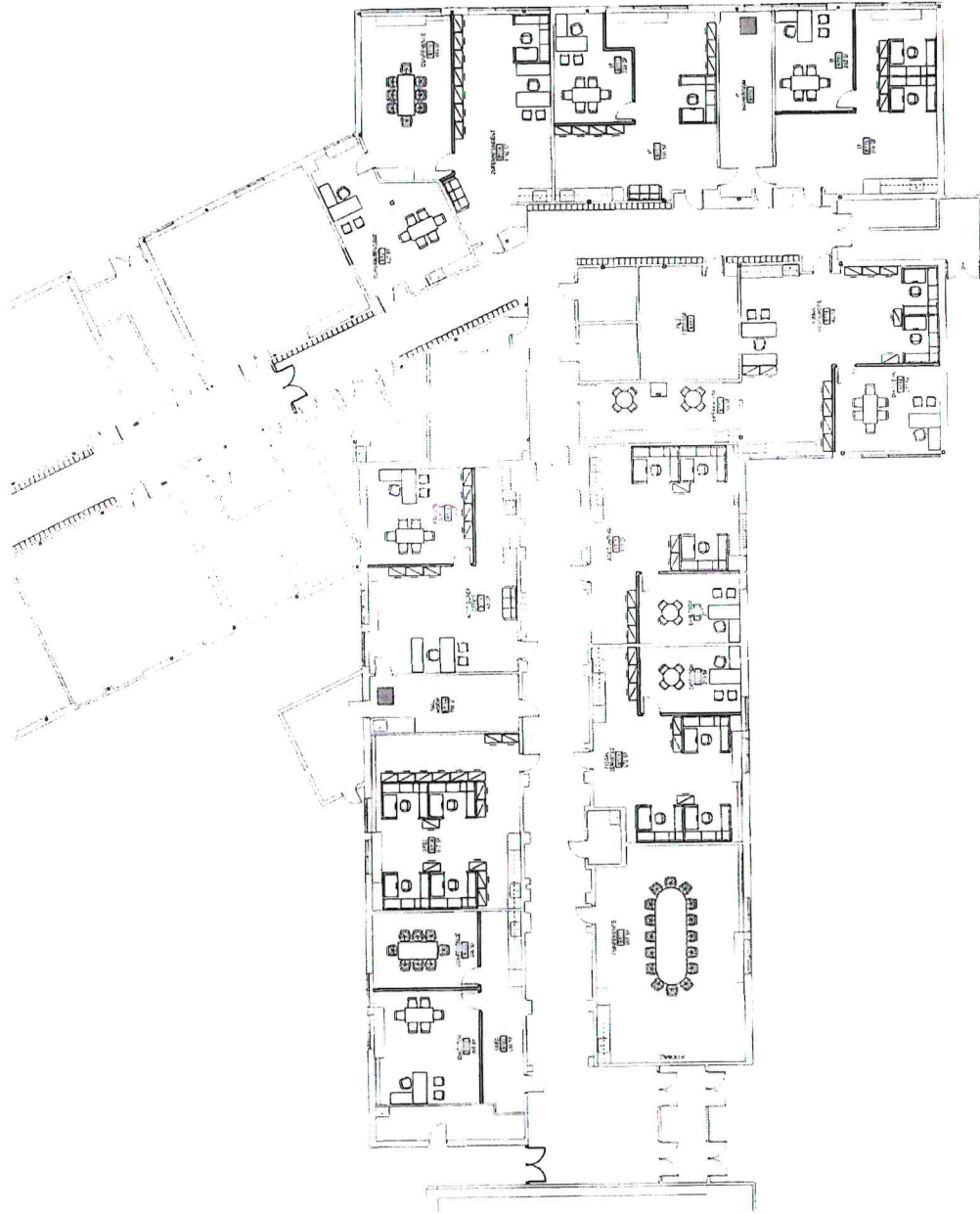
