### School Parent and Family Engagement Policy Webster County School District 2025-2026

Revised June 19, 2025

In support of strengthening student academic achievement, <u>Webster County School District</u> receives Title I, Part A funds and therefore must jointly develop with, agree on with, and distribute to parents and family members of participating children a written parent and family engagement policy that contains information required by section 1116(b) and (c) of the Every Student Succeeds Act (ESSA). The <u>Webster County School District</u> agrees to implement the following requirements as outlined by Section 1116:

- (D) Other activities are carried out, such as those described in Section 1116 of the ESSA

#### JOINTLY DEVELOPED

<u>Webster County School District</u> will take the following actions to involve parents in an organized, ongoing, and timely manner in the planning, review, and improvement of Title I programs, including opportunities for regular meetings, if requested by parents, to formulate suggestions and to participate, as appropriate, in decisions relating to the education of their child and respond to any such suggestions as soon as practicably possible.

Input and suggestions from parents, family members and all stakeholders are an essential component of the district's school improvement plans that are developed each year. All parents of students eligible to receive Title I services, community stakeholders, and all school staff are invited to attend the meeting opportunities, participate in annual surveys, to request additional support, and to share their ideas and suggestions in order to help the district, schools, and students to reach our student academic achievement goals and improve our family engagement programs. These meetings are posted in the Newspaper, on the School website, Webster County School REMIND app, Webster County School INSTAGRAM, notices are sent home with students, and the events are on the parent involvement calendar sent home at the beginning of the school year. The annual *School Improvement Input Meeting* was held on *May 5, 2025 @ 5:30 pm* to discuss plans for the 2025-2026 school year.

#### **Building Parent Capacity**

The Webster County School district will educate parents in understanding the school goals, state academic standards, school curriculum, and standardized assessments such as Georgia Milestones tests.

- · Schools will provide workshops on various topics to assist parents with the educational needs of their children, provide information regarding the Title I program and all other Federal programs grants. The dates and locations for these classes will be shared through school newsletters, websites, marquees, and automated messages.
- · Schools will provide educational literature for families to learn more about transitioning from pre-k to kindergarten, elementary to middle school, middle to high school and high school to other postsecondary opportunities and careers.
- · A parent resource room/area is located in the school Media Center. The resource room contains resources and materials, including parent guides, and additional resources to help parents work with their children at home.

#### **Building School Capacity**

- The Webster County School system will make every effort to ensure that information related to district, school, and parent meetings and activities are available to all parents. Parent notifications and resources will be sent home in the parent's native language, where applicable, and interpreters will be available at parent events and meetings when necessary.
- The Webster County School system will conduct multiple trainings for the school staff to learn and discuss strategies that will increase parent and family engagement, improve school-family communication, and build strong ties with parents.
- The Webster County School system will work to provide assistance to parents in understanding state and district academic information connected to their student's learning and progress, as well as provide information regarding the Title I program, School, Parent, Student Compact, and any other Federal Programs grants.

#### ANNUAL TITLE I MEETING

<u>Webster County School District</u> will take the following actions to conduct an annual meeting, at a convenient time, and encourage and invite all parents of participating children to attend to inform them about the school's Title I program, the nature of the Title I program, the parents' requirements, the school parent and family engagement policy, the schoolwide plan, and the school-parent compact.

#### Annual Title I Meeting -

Webster County Schools will host a meeting on Tuesday, August 5, 2025 @ 5:30pm for parents to be informed of the school-wide plans, the schools' parent and family engagement policies, and Title programs. In an effort to increase parent participation, we will give away needed school supplies! Parents will be notified by announcement on the WCS website, notices sent home with students, school social media, School Instagram; REMIND app, and a newspaper article about the date and time of the Title 1 Meeting. Parent input may be provided through the annual Title I Parent Survey sent out each spring. A 'pen and paper' survey is sent home with each student, along with a flier which contains a QR code linked to a digital version of the survey on Google Forms. The survey will contain questions related to family engagement activities with a section for parents to provide their feedback/comments. Upon receipt the WCS Leadership Team will review the data to determine which requests can be met. The team will use the findings to design evidence-based strategies for more effective parental involvement and revise the Plan, if necessary.

A Parent Involvement Calendar is sent home the first week of school. When the activities arise they are posted on the website, Instagram and the REMIND app. This year, the annual Title 1 Meeting will be held in August and parents will be informed of the Title 1 funds received. #### **COMMUNICATIONS**

<u>Webster County School District</u> will take the following actions to provide parents of participating children the following:

- Timely information about the Title I programs
- Flexible number of meetings, such as meetings in the morning or evening, and may provide with Title I funds, transportation, child care or home visits, as such services relate to parent and family engagement.

Webster County School District will send the parent and Family Engagement Policy home in the handbook that goes home with every student the first week of school or as the student enrolls, as well as a copy in the registration packet. The Webster County School District has a School council (including local businesses) that meets monthly to discuss school related issues. The input from these meetings goes into the Parent engagement and involvement planning. The CTAE Advisory committee includes business partners which give input for the school's plans. The Family Connections and local churches collaborate with the school to help meet the needs of the students. The Family Connections has quarterly meetings and we use input from these meetings in planning family engagement activities.
