## TUITION:

Tuition may be paid in one of the following methods:

- Annual Payment must be paid by **June 1**<sup>st</sup> to get the 3% discount.
- Semi-Annual Payment must be paid June 1<sup>st</sup> and December 1<sup>st</sup> to get the 1.5% discount.
- Twelve equal monthly payments due the 1<sup>st</sup> of the month each month beginning June 1<sup>st</sup> and ending May 1<sup>st</sup>.
- Twenty-four (24) Semi-Monthly payments are due the 1<sup>st</sup> and the 15<sup>th</sup> of each month beginning **June 1<sup>st</sup>** and ending **May 15<sup>th</sup>**.

# -The annual fundraiser raffle is held in order to keep tuition costs at a minimum. Each family has the option of selling 40 raffle tickets at a cost of \$25.00 per ticket (\$1,000) or opting to have the total cost of the tickets included as part of their total tuition amount.

## FEES: (Fees are Non-Refundable)

- Membership Fee (K4-6 per new family when enrolled): \$800.00 (one time only)
- Membership Fee (7<sup>th</sup> 9<sup>th</sup> per new family when enrolled): \$1,000.00 (one time only)
- Membership Fee (10<sup>th</sup> 12<sup>th</sup> per new family when enrolled): \$1,200.00 (one time only)
- New student online application fee \$25 per student

- Registration Fee per family: \$350.00 annually (Due at Registration)
- Capital Fee per family: \$275.00 annually (Due June 1)
- Supply Fee (K3-6th grade): \$60 per student (Due September 1)
- Building Fund Fee per Family: \$200 annually (Due December 1)
- Late fee for non-payment: \$50 assessed by FACTS
- NSF fee for each late payment: Assessed by your bank
- NSF fee if paying to TCA by check: \$10 assessed by TCA
