- **3. Approval of Agenda** The Agenda was approved by general consent of the Board.

4. Special Recognition

- A. SCReady Achievement The Board recognized JMS Student Miles Williams for receiving a maximum score in math on the 2023-2024 SCReady Assessment. The Board commended Miles on an outstanding accomplishment with a certificate. Mrs. Prosser also presented him with a bookbag for receiving a perfect score for the second consecutive year.
- B. SCSBA Boardmanship Institute Mrs. Deanna Green was recognized for achieving Level 2 by completing 40 training hours from the South Carolina School Board Association. The Board commended Mrs. Green on this accomplishment by presenting her with a certificate and lapel pin from the SCSBA.
