Academic Needs	The Grand Canyon Schools are committed to remain open for in-person instruction to the maximum extent possible based on available staffing. With the Omicron variant of the virus significantly impacting student attendance, the school will be utilizing ESSER funds to provide additional individual and small group interventions for students who have missed instruction time or who are not showing expected progress. To the extent possible, this additional support is provided during the regular school day during dedicated reteach and enrich periods. Additional support may be offered after school and during the summer break.
Social, Emotional and Mental Health Needs	Athletics and clubs have resumed as usual, following AIA guidelines. Field trips and events have resumed, following CDC guidelines for appropriate mitigations. A Counselor was hired under the School Safety Program – ESSER.
