1. The device belongs to the school. It is on loan to you for the school year.
2. Do not decorate your device or device case in any way (Stickers, Marker, Paint, etc).
3. Do not alter or remove the Beecher200U asset ID tags on the device.
4. Your device must be situated securely on the working surface at all times. Never touch the computer's screen. (except touchscreen devices)
5. The teachers and administration will monitor your use and have access to your school-owned device, email, and files.
6. If a student is found using the school's device for anything other than a school purpose, we have the right to rescind a student's privilege to use our device and additional behavioral consequences may follow.
7. If said right is rescinded, it will be the responsibility of the student to get digital work completed at home or before and after school. Open library hours will be available before and after school in each building.

8. The device must be carried in the school supplied case at all times. If a device is not in the protective case throughout the **entire** school year and damage occurs, you will be responsible for the full repair. Non-compliance will void the insurance.
9. Your assigned device is to be used **only** for school purposes. It is NOT a personal communication device.
10. When using your school assigned device, students must be on the task assigned by the teacher. Students must follow the teacher's instructions at all times.
11. Printing is permitted in school only with specific permission from the teacher.
12. Students are encouraged to bring a set of headphones in the case of a multimedia activity that is assigned.
13. Do not disassemble, modify, or repair your device yourself.
14. Your assigned device may not be taken to lunch, gym, or computer classes unless requested by the teacher but *must* be taken to all other classes.
15. Before any free time is given in class for computer use, all missing work must be completed.
16. Certain Internet sites are filtered or blocked - even when laptops are taken off campus. Parents are ultimately responsible for monitoring home usage.
17. The school understands accidents happen in the transport of the device. If an event happens where the device is damaged, please let your teacher know. The teacher will direct the student on their next steps. See "Device Damage Matrix" above.
18. It will be the student's responsibility to report any damage immediately when they take possession of the device for the school year.
19. There will be a repair charge associated with any breakage/damage incident. There are no longer any "Free" repairs offered. The district offers optional insurance covering theft or damage - contact your school office.

Our goal is to achieve a successful 1:1 deployment and program at Beecher School District 200U. We want our students to be able to take advantage of technology here at school and at home. However, if a student is not responsible enough to use the school's device for educational purposes, we will not allow your student to have this privilege.
