## RESOLUTION OF THE CRAZY HORSE SCHOOL BOARD ADOPTING AMENDED SCHOOL STUDENT POLICIES SECTION 4.

- **WHEREAS**, the Oglala Sioux Tribe reorganized under Section 16 of the 1934 Indian Reorganization Act (25 U.S.C. § 476) by adopting a federally approved Constitution and By-Laws, and under Article IV of the constitution the Oglala Sioux Tribal Council is the governing body of the Oglala Sioux Tribe ("OST"), and
- **WHEREAS,** Article OV, Section 1(t) empowers the Oglala Sioux Tribal Council to delegate such powers to subordinate boards while reserving to itself the right to review, and
- **WHEREAS**, the Oglala Sioux Tribal Council Resolution Number <u>84-48</u> created the Crazy Horse School Board empowered to administer and maintain the Crazy Horse School, and
- **WHEREAS**, the Oglala Sioux Tribal Council Resolution Number <u>06-90</u> adopted the Crazy Horse School Constitution and By-laws; and
- **WHEREAS,** the Oglala Sioux Tribal Council Resolution Number <u>21-157</u> adopted amended Crazy Horse School By-laws; and
- **WHEREAS,** the Constitution of the Crazy Horse School ("CHS") authorizes the School Board to manage the affairs of the School and to adopt Policies for the proper management of the School, its educational program, and personnel; and
- **WHEREAS,** the CHS Board has determined that it is in the best interests of CHS, its employees, students and community members, to adopt revised Student Policies, Section 4, the Appendices, and the accompanying Handbooks for Elementary School, Middle/High School, Athletics/Activities, and K-12 Laptop and Internet Policy;
- **NOW, THEREFORE BE IT RESOLVED,** that the CHS Board hereby adopts the attached AMENDED CHS POLICY MANUAL, STUDENTS, SECTION 4, and the accompanying Appendices, and Handbooks for the Elementary School, Middle/High School, Athletics/Activities, and K-12 Laptop and Internet Policy, which shall become effective upon adoption by this Resolution; and
- **BE IT FURTHER RESOLVED,** that nothing herein shall be deemed to be a waiver of the sovereign immunity of CHS.
- **BE IT FURTHER RESOLVED**, that the Crazy Horse School Board hereby directs the Superintendent and Principals to provide every staff member, parent/guardian, and student with a

copy of this resolution and the amended CHS School Policy Manual and accompanying Handbooks, and to post a copy of the Policy in the community for thirty (30) days.
