

Board Meeting Summary
February 10, 2026

The Board of Education met for the regular monthly meeting on Monday, February 10, 2026. The meeting was held in the Board Room of the Board of Education office located at 239 Simmons Street, Trion, Georgia.

Old Business

The board approved the following revised policies:
