Supt. Hood gave his respective report on enrollment numbers, budget update, Team of Eight Training and Senate Bill 11 Daily Prayer.

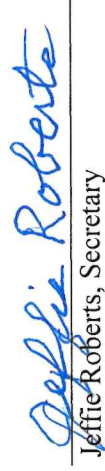
The Board entered into closed session at 6:00 p.m. and reconvened at 6:30 p.m.
